I. <u>Call to Order and Announce a Quorum Present</u>

President Calahan called the meeting to order and announced a quorum present.

II. Comments From Visitor

III. Approval of 2020-2021 Final Budget Amendments

The motion was made by Mr. Osman and seconded by Mr. Elms to approve the 2020-2021 Final Budget Amendments as presented. This includes transfers out of General Operating to Capital Projects and Child Nutrition, as well as Committed and Assigned Fund Balance designations. All amounts are contingent upon final year-end numbers.

All members voted in favor of the motion. The motion carried.

IV. Child Nutrition Prices for 2021-2022 – Information Item

Mrs. Hodges presented information regarding the 2021-2022 Lunch Prices and information/guidance from the U.S. Department of Agriculture (USDA).

V. <u>Employee Compensation Information – Information Item Overview</u>

Mrs. Hodges presented the 2021-2022 SISD Employee Compensation Overview.

VI. Approval of Updated Version of SISD State and Federal Manual

The motion was made by Mr. Osman and seconded by Mrs. Stewart to approve the Adoption of Proposed Budget for 2021-2022 as presented.

IX. Approval of Adoption of Proposed Tax Rate for 2021-2022

The motion was made by Mr. Osman and seconded by Mr. Elms that the property tax rate be increased by the adoption of a tax rate of \$1.1922, which is effectively a 2.41% increase in the tax rate. I move that the maintenance and operation rate be approved at \$0.9094, and the interest and sinking fund rate be \$0.2828 for 2021. Whereas, the board is levying an actual tax rate for maintenance and operation and an actual total tax rate that is \$0.0299 less than the actual tax rate levied in the prior year.

All members voted in favor of the motion. The motion carried.

X. <u>Approval of COVID Protocols/21-22 Safe Return to School In-Person Instruction</u> with modifications

The motion was made by Mr. Osman and seconded by Mr. Hill to approve the Stephenville ISD COVID Protocols/21-22 Safe Return to School In-Person Instruction with modifications.
