#### **SUMMARY:**

This item requests approval of 2017 – 2018 administrator appraisers for the Texas Teacher Evaluation and Support System (T-TESS), the teacher appraisal system approved for the District. This list of T-TESS appraisers have recently completed and/or provided evidence of the credentials required to perform the duties and responsibilities of a T-TESS appraiser as required by the Texas Education Agency. In accordance with Board Policy DNA (Legal) and DNA (Local), we respectfully submit the attached list of additional administrators for Board approval as T-TESS appraisers who possess the required credentials to perform the responsibilities of an appraiser within the Denton ISD.

#### **BACKGROUND INFORMATION:**

The Texas Teacher Evaluation and Support System (T-TESS) is the approved and recommended appraisal system supported by the Texas Education Agency. T-TESS was created for teachers by teachers and is aligned with the Texas Teacher Standards (TAC, Chapter 149, Section 149.1001).

#### **SIGNIFICANT ISSUES:**

Board approval of the District T-TESS appraisers is required for campus administrators to initiate the appraisal system for all district teachers.

#### FISCAL IMPLICATIONS:

#### **BENEFIT OF ACTION:**

Approval of the 2017 – 2018 T-TESS appraisers will allow campus and specified district level administrators to initiate the T-TESS appraisal system, providing valuable feedback, coaching, and goal setting through the T-TESS evaluation process with specific and intentional targets to improve student achievement and learning for both students and educators.
