

# CSCOPE District Agreement 2010-2011 New Subscription



Ector County ISD (all campuses except Bonham, Milam & OHS) agrees to participate in the CSCOPE Curriculum Management System and Content Subscription with Region 18 Education Service Center during the 2010-2011 school year.

### Description:

The CSCOPE Curriculum Management System and Content Subscription has three primary service goals:

- 1. Provide districts with a resource for implementing the state curriculum.
- 2. Provide an aligned, online curriculum with exemplar lessons.
- 3. Provide regular and sustained professional development.

#### Role of the ESC:

- Provide full access to the CSCOPE Curriculum System.
- Provide training for designated district curriculum leaders on the operations and implementation of the system.
- Coordinate with NER service providers on end-user issues.
- Provide consultation and technical assistance.
- Provide professional development at Region 18 ESC, onsite, or in cluster sites based upon the attached CSCOPE Adoption Training Sequence.
- Provide quarterly leadership professional development activities.
- Ongoing listserv support.

#### Role of the District:

- Designate a district contact/representative for coordination purposes.
- Engage in a preplanning process with ESC 18 staff on implementation sequence.
- Engage in preplanning with district staff and all stakeholders (school board, teachers, parents, etc.)
- Implement an adoption plan as collaboratively developed with ESC 18 staff, including
  - o time for administrator CSCOPE training as a team
  - o release time for teachers and principals to participate in staff development activities of the district agreement
  - o staff time for implementation of the curriculum.
- Customize CSCOPE to local needs by adding district resources and approved materials to the online system.
- Abide by the terms of the End User District License Agreement.
- Provide a current listing of all approved district domain names.
- Provide ESC 18 with teacher names, grade level course assignments, and email addresses.
- Provide ESC 18 with one (1) district curriculum user assignment.
- Participate in user group meetings.
