VI. NEW BUSINESS - FIRST READ

1. New Board Policy, Expressive Conduct

Jennifer Anderson, Associate Dean of Academic Foundations & Connections, provided the history regarding how this policy rose to the level of becoming a Board policy and the process the policy had been through to date. Jennifer also provided an executive summary regarding the purpose of the policy and information included in the policy. The policy focuses on how expressive conduct can take place on the college campus with the Board establishing the policy around time, place, and manner.

Chair Hyzy shared that Board Director Chris Groener had resigned from his position effective December 13, 2023 for personal reasons. The Board thanked Chris for his many years of services, declared the position vacant, and discussed the process and timeline for filling the position.

VII. FACULTY / STUDENT PRESENTATION

1. Musical Performance by Students

Sue Goff, Dean of Arts & Sciences, introduced Music Department Chair Lars Campbell.

Lars provided some background information regarding the music department at CCC and the classes that are offered. Lars brought students from one of the classes to play a song for the Board.

Once the performance was over, each of the performers introduced themselves: Aidan Storm, German Ocampo Hernandez, and David Asuncion Agustin on saxophone, Micah Scothorn on keyboard, Celia Collofello on bass, and Will Madzier on drums.

Each member told us a little bit about themselves and the Board asked what they could do to support the students. They said they needed more practice rooms because it gets too busy during the lunch break.

VIII. ASSOCIATION REPRESENTATIVE REPORTS AND COMMENTS

Associated Student Government (ASG)

2. Full-Time Faculty Association (FTF)

Nora Brodnicki, FTF President, shared information regarding the trip she took students on to Ireland, the Art's Department Instagram, and donated art.

3. <u>Associate Faculty (Previously Part-Time Faculty) Association</u> (CCCAFA) Christopher Zimmerly-Beck, CCCAFA President, highlighted the CCC students, the work finished up for the end of the term, and the legislative work the Board is doing.

4. <u>Classified Association</u> (ACE)

Kelly White, ACE President, shared information regarding a recent conference attended and the Classified Associations new process for distributing professional development funds.

IX. COLLEGE REPORTS

1. Bond Update

Jeff Shaffer, Vice President of Finance and Operations, provided a bond update including language that categorizes the projects into three categories: 1) Preparing Students for Success Through Modernizing Teaching and Learning Spaces 2) Preserving our Ageing Assets 3) Enhancing our Connections with our Partners and Community. The total would come to a total of \$136 million in projects, but with the potential of the OSU Extension match opportunity of \$10 million and the state funding grant match for two projects over the two-year period of \$16 million, that would bring it down to \$110 million.

2. Audit Report

Jeff Shaffer, Vice President of Finance and Operations, introduced Darren Born from Kenneth Kuhns & Co.

Darren Born, Auditor from Kenneth Kuhns & Co, provided an overview of the audit process, highlighting the three-week duration, on-site work at the College, and access to digital systems for record review. He emphasized the College's well-maintained financial records and books. As the auditor, his role was to challenge presented information, confirm external sources, and express an opinion on the fairness of financial statements. He reported issuing a clean, unmodified opinion, indicating the statements were fairly presented. Darren touched on key revenue and expense figures, such as tuition and fees, state and federal grants, and one-time employee retention credit. Non-operating revenues included state appropriation and property

tax revenue, with explanations for fluctuations. Darren mentioned the impact of accounting for pension liabilities on operating expenses, referencing a schedule for clearer insights. He highlighted additional information in the document, including financial statements for the foundation, notes, required supplementary information on pension liability history, individual fund financial details, and reports related to Federal aid compliance. Born concluded by stating that the audit found no issues in the Federal student financial aid programs.

There was a question from the Board about how frequently the College changes auditing firms and it was about every five years.

3. President's Report

President Cook shared information regarding what the new HECC funding formula looks like as far as the change in funding the College should be expecting, which should not change significantly.

X. BOARD OPERATIONS

1. Board Chair Business Report

Chair Hyzy shared that several of the Board attended the 2023 Oregon Business Plan Leadership Summit. She also shared a public statement regarding President Tim Cook's performance evaluation.

2. CCC Education Foundation Report

Chair Hyzy shared that the CCC Foundation finished the year with a strong Year End Appeal of \$85,234 being raised so far this month with close to \$10,000 for basic needs support. They will have a successfully hired Caitlin Sullivan from West Linn-Wilsonville School District to fill the Foundation's Advancement Officer position. Caitlin will start on January 8, 2024. The Foundation's flagship event Rise Up! is being planned for May 15, 2024 and there is a flier at your seat at the dais. Please share this information with anyone you wish to invite.

3. Oregon Community College Association (OCCA) Report

Jane shared information about the last OCCA Board meeting including the highlight of hiring a recruiting firm to start the process for hiring a new Executive Director.

4. Board of Education Community Reports

Each Board member provided updates about things they had participated in over the last month or two.
