2. BOARD VACANCY INTERVIEWS

- a. Candidate interviews for the Board Zone 5, Position 1 Vacancy
 - i. The Board conducted interviews for the vacant Board seat. Three candidates were interviewed.

 - ii. Candidate Introductions & Opening Statements
 - 1. Each candidate was given three minutes for an opening statement to express their interest and qualifications for the board position.

iii. Interview Questions & Candidate Responses

- 1. Candidates were asked a series of standardized questions by the MESD Board, including:
 - a. **Renee Anderson**-Please tell us why you are interested in serving on the board and where do you think your strengths and weaknesses fit in with the current board?
 - b. **Jessica Arzate**-What is your definition of equity in the school district, and what would you do to improve equity in the district? How do you believe a school board member can be most effective in making long-lasting, substantial, positive changes for students that are rooted in equity?
 - c. **Danny Cage**-What are the three most important challenges that face the district, and how would you address them?
 - d. **Katrina Doughty**-How will you help this board and this district close the opportunity gap? What are the factors on which you will base your decisions as a school board member?
 - e. **Denyse Peterson**-Why do you believe you are the best applicant for this position? Are you interested in the position only until the end of the interim term (June 30, 2025) or do you plan to run for election to complete a full term (through June 30, 2029)?



f. **Helen Ying**-Effective board members must engage in a variety of relationships; for example, with the superintendent, staff, other board members, parents, and the community. How do you perceive a board member's relationship with each of these?
