Eduardo Trevino, Assistant Superintendent for District Operations welcomed the Board of Trustees and the Superintendent and thanked them for allowing them the opportunity to make this presentation. Mr. Trevino stated that the district has been in a financial crisis for the past three (3) years and is doing the best with what each department has been allocated with. At this time administrators made their presentation as follows:

A. Maintenance & Facilities Department- Pedro Felan, Maintenance & Facilities Director provided a brief description of his years of service with the district, education, certifications, licenses, and trainings. The department has state licensed employees in the electric, plumbing and HVAC fields and they attend yearly continuing education courses for certifications. All employees in the department go through training, and the employee handbook is also provided to all employees. A *Department Handbook* has been recently created and is pending Human Resources review. Mr. Felan went over the department's organizational chart, employee daily schedules, and assignments/operations. Also reviewed were procedures for purchasing materials, work orders, fire safety, absenteeism, 2013-14 budget, and the department's Mission Statement. **Department needs, issues, and concerns were also discussed with the Board**.

B. Transportation Department- Mr. Humberto Araiza, Transportation Director, provided a brief description of his years of service with the district, education, certification, licenses, and trainings. Mr. Araiza addressed the Board on employee trainings, which included safety & security procedures, good working habits, and the type of licenses needed to operate a district school bus. Random drug testing on bus drivers are preformed, and Employee Handbooks are provided to all employees. Also addressed was the employee absenteeism, bus overloads, driver schedules, turnover of employees, student pickup/drop-off, employee/student conduct on buses and transportation funding. Department needs, issues, and concerns were also discussed with the Board.

C. Food Service Department- Mr. Humberto Araiza, Transportation Director made the presentation for this department. There are a total of 340 food service employees, which includes the managers, assistant managers, cooks, secretaries, warehouse staff, and administration. The district is regulated by the Offer Versus Service method, which is designed to reduce food waste, and food costs, offering a child a choice to preorder a meal. It is also designed to promote good food habits and nutritional education. (More vegetables and fruits) Nutritional Facts comes in CN Labels (Child Nutrition Label) in all food items and have been approved by USDA. The CN Labeling Program, are generally purchased by food service providers and clearly identified with contribution of the products and meal patterns requirements. **Department needs, issues, and concerns were also discussed with the Board.**

D. Athletic Department- Mr. Edward Graf, Athletic Director addressed the Board of Trustees and presented the athletic department procedures and guidelines. Eagle Pass ISD is a member of UIL and is guided by the rules set forth in the UIL Constitution and Contest Rules. Schools are aligned by enrollment every two years. The enrollment numbers for Eagle Pass ISD 2014-2016 are as follows: EPHS is now a 6A school with an enrollment of 2258 and CC Winn is a 5A school with an enrollment of 1992. The athletic department has 170 coaching positions, 4 certified athletic trainers, 7 athletic grounds maintenance crewmembers, 8 elementary grounds maintenance crewmembers, 9 SAC custodians and grounds maintenance crewmembers, 1 athletic dept. secretary, 1 clerk, and 1 athletic director. There is 26 high school athletic programs, which 1442 high school students participated in the 2013-2014 school year, for a total of 474 home games and 571 were played away. Educational values and sportsmanship, teamwork, discipline, responsibility leadership, respect for self and others, and commitment are always emphasized through completions. Coaches are teachers first, all coaches receive certification from UIL on a yearly basis for completion of the Rules Compliance Program. Coaches are also certified in CPR, AED and First Aid. Department needs, issues, and concerns were also addressed with the Board.

E. Health Services Department- Minerva Rankin, RN Nurse Coordinator addressed the Board of Trustees with the department's procedures and guidelines. Services are provided to all 24 campuses in the district-PK-12th grade with an enrollment of 15,000 students. RN's, LVN's, and CNA assignments were addressed, explanation of types of medications, clinical visits, management of chronic health problems, students with special needs, basic student health services were discussed. Staff training includes good bookkeeping (reports), duties, and responsibilities, hands-on orientation for substitute nurses, sexual harassment training, and student information portal program. In-services are conducted on student needs, immunization clinics, and state mandated screening, referrals, first aid, and certifications. The health department has been in operation without a medical director, therefore rely on the following references: Texas Board of Nursing, TX Guide to School Health Programs, School Nurse Consultant, DSHS, Region 20, Educational Specialist, National Association of School Nurses, TX School Nurses Organization, School Nurse Connection, and US Dept. of Health & Human Services Center for Disease Control & Prevention. **Department needs, issues, and concerns were discussed with the Board**.
