 4.3 Ensure Strategic Alignment of Resources

BACKGROUND INFORMATION:

In August 2022, the District sought a qualified Insurance provider to provide Liability and Automobile Insurance Coverage for the district beginning the 2022-23 School Year. This insurance covers automobile liability, automobile physical damage, school liability (including professional, legal, general and employee benefits), privacy and information security and violent acts. We directly reached out to four providers that year that provide or have provided School District Insurance coverage in the Coastal Bend area. We received one response from TASB Risk Management who was the incumbent provider for the District. We have had great service and support from TASB and their online tool for claims is customer friendly.

RECOMMENDATION:

Administration recommends to renew the contract with TASB Risk Management Services for Liability and Automobile the 2025-26 School Year.

FINANCIAL IMPACT:

2025-26 Renewal Cost: \$83,284 2024-25 Cost: \$77,806 2023-24 Cost: \$61,075 2022-23 Cost: \$53,288

Auto Liability and physical damage: increase of \$5,024 (17%) Across the Board, all members are seeing increases in auto liability due to the higher cost of automobiles, higher repair costs, increasing litigation costs, and there are still some automobiles that have issues with the supply chain for parts.

School Liability: Increase of \$454 (1%)

Privacy & Information Security: stayed the same
