Re: Bid #1163, Bid Package #2 – Eastern (Ordean) High School Earthwork/Site

Demolition – Contract #3100 – Change Order #6 – Veit & Company, Inc.

Bid #1163 – Eastern (Ordean) High School Bid Package #2, Earthwork/Site Demolition was approved at the Regular School Board meeting on August 18, 2009 with a bid of \$1,557,950.00.

Change Order #6 to this bid is for soil corrections beneath the foundations at the southern end of the retaining wall resulting in an <u>increase</u> of \$22,729.00 bringing the new contract sum to \$1,883,035.00. With this amount, the project remains within the budgeted amount at this site.

I am recommending approval of Change Order #6 to the Agreement between Independent School District #709 and Veit & Company, Inc. pursuant to School District Bid #1163 – Eastern High School Bid Package #2 – Earthwork/Site Demolition (Contract #3100)
