Re: Debt – Resolution of Intent to Issue Working Cash Fund Bonds

Date: June 18, 2019

## Background:

Currently, the District has two types of outstanding bond debt. One series of debt is in the form of DESB (Debt Extension Service Base). This type of debt allows the District to levy without voter approval, as determined by the tax cap legislation. The second type of debt the district maintains is referendum debt. In 1991, the voters approved \$8.5 million debt issuances. Both series (2009A and 2009B) were refinanced in 2009 and are callable on November 1, 2019. Most debt certificates cannot be refinanced or paid off within 10 years of being issued.

### **Situation:**

As we have discussed, it is advantageous for the District to refund the Series 2009A and Series 2009B Bonds for savings this October of 2019 to coincide with the current redemption date of the bonds. At the same time the District will issue new money working cash fund bonds for expenditure on capital projects. Due to the fact that the District will be issuing/refinancing new debt, the District will need to hold a public hearing and pass a resolution of Intent to Issue Working Cash Fund Bond. For your convenience, I have attached the following documents that will be required as part of this transaction:

- 1). Resolution of Notice of Intent
- 2). Petition for Notice of Intent
- 3). Notice of Public hearing concerning the intent
- 4). Notice of Public hearing published in local paper

#### **Recommendation:**

That the Board of Education approve the attached Resolution expressing official intent regarding certain capital expenditures to be reimbursed from proceeds of an obligation to be issued by the District.

Board of Education would consider the adoption of a resolution declaring its intention to issue
working cash fund bonds pursuant to Article 20 of the School Code and directing that notice of
such intention be published.
Whereupon Member presented and the Secretary read by title a

resolution as follows, a copy of which was provided to each member of the Board of Education

prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION declaring the intention to issue \$1,100,000 Working Cash Fund Bonds of School District Number 13, DuPage County, Illinois, for the purpose of increasing the Working Cash Fund of said School District, and directing that notice of such intention be published in the manner provided by law.

WHEREAS, pursuant to the provisions of Article 20 of the School Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the "Code"), a fund to be known as a Working Cash Fund (the "Fund") may be created and maintained in and for School District Number 13, DuPage County, Illinois (the "District"), in the manner prescribed in the Code, for the purpose of enabling the District to have in its treasury at all-time sufficient money to meet demands thereon for expenditures for corporate purposes; and

WHEREAS, the District has heretofore created and maintained such Fund in the manner prescribed by the Code; and

WHEREAS, under the provisions of the Code, the Board of Education of the District (the "Board") is authorized to incur an indebtedness and issue bonds as evidence thereof (the "Bonds") for the purpose of increasing the Fund; and

WHEREAS, the Board has determined and does hereby determine that it is advisable, necessary and in the best interests of the District that the Fund be increased and that the District incur an indebtedness and issue Bonds as evidence thereof in the amount of \$1,100,000 for said purpose; and

WHEREAS, before such Bonds may be issued for said purpose, the Board must adopt a resolution declaring its intention to issue such Bonds for said purpose and direct that notice of such intention be published as provided by law:

Now, Therefore, Be It and It Is Hereby Resolved by the Board of Education of School District Number 13, DuPage County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Declaration of Intent. The Board hereby declares its intention to avail of the provisions of the Code, and to issue Bonds in the amount of \$1,100,000 for the purpose of increasing the Fund and enabling the District to have in its treasury at all-time sufficient money to meet demands thereon for expenditures for corporate purposes.

Section 3. Notice of Intent. In accordance with the provisions of Section 5 of the Local Government Debt Reform Act of the State of Illinois, as amended, notice of said intention to avail of the provisions of Article 20 of the Code and to issue Bonds for the purpose of increasing the Fund shall be given by publication of such notice at least once in the *Daily Herald*, the same being a newspaper of general circulation in the District.

Section 4. Form of Notice. The notice of intention to issue the Bonds shall be in substantially the following form:

## NOTICE OF INTENTION OF SCHOOL DISTRICT NUMBER 13, DUPAGE COUNTY, ILLINOIS TO ISSUE \$1,100,000 WORKING CASH FUND BONDS

PUBLIC NOTICE is hereby given that on the 24th day of June, 2019, the Board of Education (the "Board") of School District Number 13, DuPage County, Illinois (the "District"), adopted a resolution declaring its intention and determination to issue bonds in the aggregate amount of \$1,100,000 for the purpose of increasing the Working Cash Fund of the District, and it is the intention of the Board to avail of the provisions of Article 20 of the School Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto, and to issue said bonds for the purpose of increasing said Working Cash Fund. Said Working Cash Fund is to be maintained in accordance with the provisions of said Article and shall be used for the purpose of enabling the District to have in its treasury at all-time sufficient money to meet demands thereon for expenditures for corporate purposes.

A petition may be filed with the Secretary of the Board (the "Secretary") within thirty (30) days after the date of publication of this notice, signed by not less than 1,062 voters of the District, said number of voters being equal to ten percent (10%) of the registered voters of the District, requesting that the proposition to issue said bonds as authorized by the provisions of said Article 20 be submitted to the voters of the District. If such petition is filed with the Secretary within thirty (30) days after the date of publication of this notice, an election on the proposition to issue said bonds shall be held on the 17th day of March, 2020. The Circuit Court may declare that an emergency referendum should be held prior to said election date pursuant to the provisions of Section 2A-1.4 of the Election Code of the State of Illinois, as amended. If no such petition is filed within said thirty (30) day period, then the District shall thereafter be authorized to issue said bonds for the purpose hereinabove provided.

Section 6. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 7. Repealer and Effective Date. All resolutions and parts of resolutions in conflict herewith be and the same are hereby repealed and that this Resolution be in full force and effect forthwith upon its adoption.
