## 4. UNFINISHED BUSINESS

4.1. Preliminary Approval of the 2026-2027 School Year Calendar (third reading)

Associate Superintendent Mindy Westover presented a revised 2026-2027 school year calendar since the board's previous review on November 4. The revised calendar included an even balance in the number of instructional days in the first and the second semesters. The revised calendar has been patterned after the 2025-2026 calendar and reflected the following highlights:

- New teachers report to work on Wednesday, July 22, and returning teachers on Tuesday, July 28.
- The first day of school is Monday, August 3.
- During the first week of school, elementary early release and middle school late start are observed.
- During the first week of school, the high school begins at 8:35 a.m. and observes a regular day rotating schedule.
- The last day of school, Wednesday, May 19, is a half day for students and a full day for staff.
- Fall break, October 5 9, is a full week.
- K-12 parent/teacher conferences are held mid-week October 20, 21, and 22, with Monday and Friday of that week full days for all schools.
- Pre-K parent/teacher conferences are by appointment only, September 21 October 2, and April 19 -30.
- The semesters are evenly divided (90/90 days).
- The last contract day for teachers, Thursday, May 20, is a full day for staff.

Items that did not change since the board's review of the previous version of the 2026-2027 calendar included:

- Veteran's Day, Wednesday, November 11, is a student holiday.
- A short week schedule is observed at the high school during the week of Thanksgiving and the week of first semester exams.
- Winter break includes three weekends.
- Spring break will be March 22 26, 2027.

A board member requested a technical change to the color coding of days after the last day of school in May 2027.

Board members expressed appreciation to district administration for seeking additional feedback from school administration and for developing an alternative calendar to balance the number of instructional days in each semester.

Upon a motion by Doug Hadley and a second by Carole Siegler, the governing board preliminarily approved the 2026-2027 school year calendar, as amended.

4.2. <u>Approval of Revisions to Policy DJE and Regulation DJE-R, *Bidding / Purchasing Procedures* (second reading) Associate Superintendent Westover shared no revisions to the policy and regulation concerning bidding and purchasing procedures to ensure that grant-related purchases are not made from an entity that has been suspended or debarred by the federal government since the governing board's review on November 4.</u>

The federal government prohibits expending federal funds or goods and/or services from any entity suspended or debarred from doing business with the federal government. Suspension and debarment are actions taken by the federal government against organizations or individuals who have committed fraud or a criminal offense in violation of federal law. In accordance with uniform guidance 2 CFR 200.214, the policy and regulation have been revised to include language to check for procurement contracts for goods and services awarded under a non-procurement transaction (e.g., grant or cooperative agreement) that are expected to equal or exceed \$25,000, for debarment or suspension of any agency, entity, and its principals.

In the policy, proposed revisions include the addition of the Code of Federal Regulations Title 2, the new adoption date, and the specific federal regulations to the legal references section. In the regulation, proposed revisions include a revised first paragraph to include the Code of Federal Regulations with a statement that purchases must be in accordance with the regulation and a new section titled *Federal Regulations for Suspension and Debarment Verification* to include specific language regarding the requirement to check procurement contracts for goods and services awarded under a non-procurement transaction that are expected to equal or exceed \$25,000 for debarment or suspension of any agency, entity and its principals.

Upon a motion by Doug Hadley and a second by Gina Mehmert, the governing board approved policy DJE and Regulation DJE-R, *Bidding / Purchasing Procedures*, as presented.

5.2. Consideration of Proposed Arizona School Boards Association (ASBA) Bylaws

President Jackson presented the proposed amendment to the bylaws. The ASBA Governance Committee, with unanimous approval from the ASBA Board of Directors, has proposed changes to the bylaws to enhance governance practices within their association. These updates are designed to improve transparency, accountability, and member engagement to ensure ASBA operates with the highest standards of integrity and effectiveness. The proposed changes aim to strengthen the association's ability to adapt to emerging challenges and better serve their diverse membership.

Board members requested to table the item until more information related to the proposed changes are provided for additional review. This item will return to the regular meeting agenda on December 10.

# 6. DISCUSSION / REPORTS

#### 6.1. Arizona Legislative / Governmental Activity

Board members discussed the future of Proposition 123, Governor Katie Hobbs' plan to raise pay for educators and support staff, and to improve school safety without tax hikes.
