### **Introduction**

Each year at this time the District sets the school fees for the upcoming school year. It is important to have the fees set at this time in order for the District to determine one of their revenue sources as well as for Kindergarten enrollment in February.

### **Situation**

There are two primary fee sources; Student and Facility. Each year with student fees, we are going to offer a discount if paid prior to July 1<sup>st</sup>. Based upon my discussion with the staff, it is important we know our enrollment as early as possible. This allows us to hire new staff sooner and develop bus routes. When analyzing student fees, the following was taken into consideration:

1. Student fees will not increase this year.
2. The District has invested in technology in previous years and is continuing to provide more services in this area.
3. Milk fees – Will not increase. The district has raised the fees in prior years, in order to bring the District to a break-even point.
4. An incentive to pay prior to July 1<sup>st</sup>
5. At the prior year's Board of Education meeting, it was discussed to have an overall \$20 fee increase rather than breaking out fees for clubs and athletics. Last year, we increase fees to cover said costs.

### **Requirements**

- All fees must be paid in full at time of registration.
- Fees paid prior to July 1<sup>st</sup> receive a discount.
- Parents who are unable to pay fees due to hardship have the affordance of completing a "Fee Waiver Request" form.

Each year building fees are evaluated and determined, this is the fifth year the administration is bringing a recommendation to the Board of Education. The schedule of building rental fees is part of the facility handbook.

Included in this memo is a schedule with an itemized fee structure for both student and facility fees.

### **Recommendation**

This is a discussion item only, and does not require any action by the Board of Education.

Approved teacher activities  
Approved intergovernmental agreements and leases  
Independent Tutoring Services for SD 13 Students (SD13 Staff included)

**Group II** Non-Profit Groups (\*Child-Oriented)  
Boy/Girl Scout and similar groups  
Religious groups  
Cultural groups  
Recreational groups  
  
\*Child-oriented shall be defined as the age group of children who are normally served by the educational program of District 13; i.e., preschool through 8th grade. A percent of the participating children shall live within the boundaries of School District 13. See Rules and Regulations: Indoor Facilities, page 8; Outdoor Facilities, page 9.

**Group III** Non-Profit Groups (\*\*Adult-Oriented)  
Civic groups  
Governmental entities  
Other taxing bodies within District 13 boundaries  
Religious groups  
  
\*\*Adult-oriented shall be defined as any group whose target audience is adult and not primarily students in preschool through 8th grade. 90% of the participating adults shall live within the boundaries of School District 13.

**Group IV** Profit Groups - Charging Fees  
Commercial groups for recreational purposes with participants residing within District 13 boundaries

**Group V** Board Approved Leases or Partnerships (requires Board authorization for building use)  
Commercial groups for recreational purposes with participants residing outside District 13 boundaries
