- <u>Nutrition Services</u> summer food program total to date 4184, weekly average 282.25, highest week 7106 (8/12) 127.32% increase
- <u>Transportation</u> provide services to 12 different programs, CTE programs to CCC, EHS summer school, July 4,757.95 miles. Installation of new software-new wifi camera, GPS tracking (for safety) improved/efficient routes created. ### G.1. Bond Polling Results

- Ben Patinkin
- A survey of 400 likely voters in the Estacada School District was conducted by telephone using professional interviewers.
  A voter file sample was used and a sample of registered voters was pulled from across the District. Quotas and weights were then set to reflect a likely November 2024 electorate, separately.
  Interviews were conducted July 29-31, 2024
  The margin of error for the sample as a whole is plus or minus 4.9 percentage points at the 95% level of confidence. The margin of error for subgroups varies and is higher.
- Voters are divided and undecided on the proposed bond measure
- Gaps exists based on age, gender, educational attainment and homeownership
- The bond renewal fares poorly with non parents
- Reiterating to voters that this is not a tax increase results in a raise of support
- The statement "Let me tell you a little more about this bond for the Estacada School District. The bond is designed to strengthen security and fire safety systems to better protect students and staff in case of an emergency. It will increase student and staff safety by removing asbestos, replacing rusty piping, repairing leaky roofs and updating electrical wiring and plumbing. These critical repairs will be designed to extend the life of school buildings. The bond will also pay to upgrade job training spaces to improve and modernize career and technical education programs. Having heard this, would you vote "yes" or "no" on this proposed bond for the Estacada School District?
