BACKGROUND:

The BISD has been using SameGoal since the 2022-2023 school year. SameGoal is a web-based special education IEP management platform that helps schools create, manage, and track IEP documentation, through real-time collaborative editing, automated compliance checks, student information system integration, electronic signatures, and state-aligned forms; it centralizes student information, streamlines workflows for teachers and administrators, supports parent access, and provides reporting and deadline tracking to keep districts compliant with state performance plan indicator and state and federal mandates.

BACKGROUND:

RFP #23-150 for the purchase of a Special Education IEP Management Software. A new special education management software is needed because the current software, IEPplus, is no longer utilized by any other district in Texas and is no longer being upgraded and therefore does not meet the needs of BISD. SameGoal is a web-based documentation, management and compliance software platform for Special Programs. SameGoal was one of five IEP software companies that submitted a proposal. SameGoal was chosen by a software ranking committee comprised of BISD special education teachers, therapists, diagnostician, and administrators.

5 Proposals were received.
First time bid.
