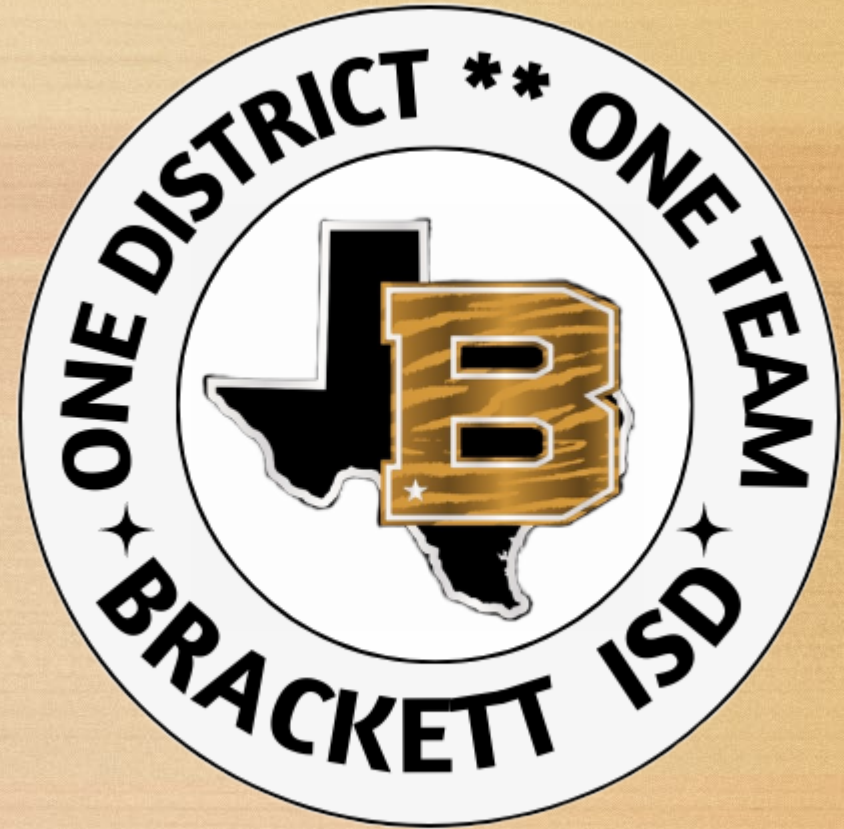

Texas Assessment Performance Report

What is it and why is it important

- An annual district and campus report, available to the public, showcasing information:

Highlights

Academics

- College, Career, and Military Readiness: 90.2% of Brackett ISD graduates are college, career, or military ready compared to the state average of 81.8%
- STAAR Performance: The district outperforms the state in reading/ELA with 82% of students at Approaches Grade Level or Above compared to 76% statewide.
- Advanced/Dual-Credit Course Completion: 36.6% of students in grades 9-12 complete advanced courses compared to 25.1% statewide.
- Industry Based Certification: 63.4 of Brackett ISD students graduated with an industry certification compared to the state 34.9%

Highlights

Gradation and Retention

- 4-Year Graduation Rate: 97.8% for Class of 2023 compared to state's 90.7%
- Low Dropout Rates: Annual dropout rate for grades 9-12 is 0.0% compared to state's 1.9%
- Brackett ISD Chronic Absenteeism is 13.3% compared to states 19.0%
- Brackett ISD attendance rate 94.6% up from 94.1% and higher than state 93.6%

Teacher Compensation and Development

- Teacher Incentive Allotment: Brackett ISD has not participated in the Teacher Incentive Allotment but is in the process of submitting application in April 2026.
- Beginning Teacher Salary: \$55,238 compared to \$63,751 statewide
- Turnover rate for Teachers: Brackett ISD turnover rate is 17.5% lower than state 18.8%

Student Demographics

- Economically Disadvantaged Students: 58.5% versus 60.5% statewide, indicating higher needs
- Intellectual Disabilities: 50.5% compared to 48.3% statewide, suggesting greater special education needs
- At-Risk Students: 40.9% versus 53.5% statewide

Instructional Factors

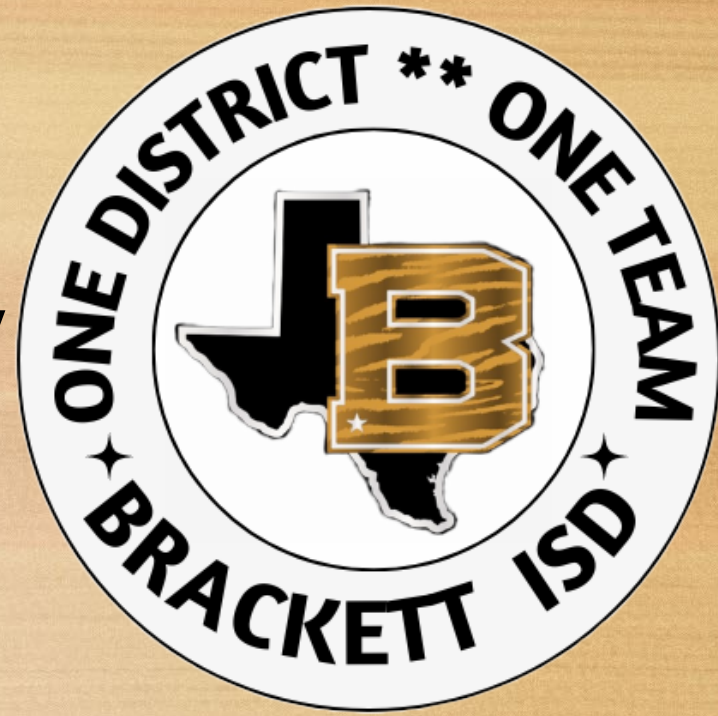
- Class Sizes: Consistently smaller than state averages; number of students per teacher 10.5 vs state 15.0 ;
 - Grade level examples
 - Grade 1 BISD – 15.0 state 19.2
 - Grade 3 BISD – 12.7 state 20.1
 - Grade 6 BISD - 12.3 state 19.8
 - ELA 9-12 BISD – 8.6 state 16.4
 - Math 9-12 BISD – 8.4 state 17.8
- Teachers by years of experience: 21- 30 years 23.3% vs state 14.1%
- High New Teacher Percentage: 10.1% of teachers have 0-5 years experience versus 7.3% statewide
