## **CAREER - TECHNICAL EDUCATION MEMORANDUM OF AGREEMENT**

THIS AGREEMENT, made and entered into by the CANYON-OWYHEE SCHOOL SERVICE AGENCY, located in Canyon and Owyhee Counties, State of Idaho, hereinafter referred to as the Agency, and COSSA ACADEMY SCHOOL DISTRICT NO. 555, State of Idaho, hereinafter referred to as the District, is for the 2023-2024 school year beginning JULY 1, 2023, and ending JUNE 30, 2024.

- 1. The Agency agrees to provide education and/or training programs, in accordance with the rules and regulations established by the State Board of Education and/or the State Board of Career Technical Education, for students residing in the District, accepted by the Agency, and as assigned to designated programs for Auto Technician, Nurse Assistant, EMT, Heavy Equipment/Diesel, Construction Trades, Culinary, Welding, Pre-Engineering, Law Enforcement, or other programs as may be developed. The Agency further agrees to provide the District the following information:
  - a. The daily attendance of each student at times requested by the District and as necessary to meet the reporting schedule established by the State Department of Education.
  - b. Student evaluation and grade for periods as established by the calendar adopted by the Agency, including an annual statement of progress made by each student.
  - c. Date and reasons for termination of any student who consistently fails to adhere to the rules and regulations of the Agency.
- 2. The Agency agrees to provide the Department of Career Technical Education with all reporting information requested, and further agrees to provide the District with program evaluation information.
- 3. The District agrees to pay \$93,938.00 for the Agency Career Technical classes for the 2023-2024 school year. There are to be four equal payments of \$23,484.50.
- 4. The District agrees to pay the Agency their portion of an allocation designated for a stipend for certified teachers who have attained a Occupational Specialist educational achievement; to be paid to the Agency in May; provided the teacher is eligible to receive that stipend.

- 5. The District agrees to pay the Agency their portion of an allocation designated for a stipend for certified teachers who have attained a BA/OS+24 or MA educational achievement; to be paid to the Agency in May; provided the teacher is eligible to receive that stipend.
- 6. The District assumes the responsibility for the provisions of any transportation that may be needed to get students to Agency Career Technical training sites.
- 7. The Agency and the District agree to comply with and abide by all pertinent statutes of the State of Idaho, and such rules and regulations as the State Board of Education may legally prescribe, which are made a part of this contract as though set forth herein at length.
- 8. The term of this agreement shall be for one year beginning JULY 1, 2024 and shall be automatically renewed annually for twelve months thereafter, unless terminated by the Agency or the District by giving thirty (30) days' written notice to the other party prior to the Agency February Board meeting.
