## **INDEPENDENT SCHOOL DISTRICT NO. 709**

MEMORANDUM OF AGREEMENT, made this **29th day of December**, **2011**, between Independent School District No. 709, a public corporation, in the State of Minnesota, party of the first part, hereinafter called "ISD 709," and **ServiceMaster Superior-Duluth-Cloquet** party of the second part, hereinafter called "Contractor",

WITNESSETH, that the said Contractor, in consideration of the covenants and agreements herein mutually entered into, does for itself and for its successors, assigns, executors and administrators covenant, promise and agree to and with ISD 709 that Contractor shall and will at its own proper cost and expense and according to the best of its art and ability, do and perform all the work and furnish all equipment and materials (except only where otherwise especially provided herein to the contrary) which may be required in performing and completing the specified work or services: To perform emergency cleaning and /or restoration services required to restore building damage caused by a release of glycol heating fluid at the Duluth Denfeld High School. This release of fluid resulted from a failed plumbing joint in the heating system installed by Shannons' Inc.. The leaked fluid subsequently caused damage to the Denfeld High School Building and some of its contents. This Agreement is for work to investigate, test, and

perform emergency cleaning, drying, repair, and resurfacing, and refinishing, and /or replacement of building materials and contents related to the leak and only when such work or service is covered by Shannon's Insurance.

Shannon's Insurance Company, CNA Policy #: 4027100614; Claim #: E2830910. CNA has retained the services on John Hargesheimer with Moe&Nevin Insurance Adjusters.

The work to be performed by <u>ServiceMaster Superior-Duluth-Cloquet</u> pursuant to this Agreement may include work requested by ISD 709 and that authorized by CNA Insurance or their property adjuster representative Moe & Nevin. Total contract award amount is estimated at \$6,916.01 (Estimate dated 12/27/11 attached) but will be based on the actual labor time and material provided by the Contractor. As stated above, and together with all other words connected therewith or necessary thereto, and in accordance with the plans and directions by ISD 709 and CNA Insurance and made from time to time as the work proceeds, said written directions to form a part of this contract.

#### **AUDIT:**

Subject to 1998 Minnesota Laws ch 386, art. 1, § 6: the books, records, documents, accounting procedures and practices of the Contractor relevant to the project are subject to examination by ISD 709 or its designated representative and

the State Auditor or Legislative Auditor as deemed appropriate for three (3) years after the final payments are made and all other pending matters are closed.

## CONSIDERATION:

ISD 709, in consideration of the due and faithful performance of the covenants and agreements referred to herein and as directed by ISD 709 and or by Moe&Nevin Insurance Adjusters, ISD 709 promises and agrees to pay the Contractor only the amount of the Contractor's invoice that is fully covered and paid by CNA Insurance Policy #: 4027100614, Claim #: **E2830910**.

To the extent permitted by Shannon's inc. and CNA Insurance, ISD 709 hereby authorizes CNA Insurance to make direct payment to ServiceMaster for their work provided ISD 709 receives a copy of invoices and copy of check used for payment.
