**RESOLUTION RE: THE CERTIFICATE  
OF TAX LEVY FOR 2023**

**WHEREAS**, on the 11th day of December 2023, the Board of Education of Geneva Community Unit School District No. 304 estimated the amounts necessary to be levied for tax year 2023; and

**WHEREAS**, the estimated amounts necessary to be levied for tax year 2023 are greater than or equal to 105% of the aggregate levy extension of the preceding year, thereby requiring a Truth in Taxation hearing; and

**WHEREAS**, the Board of Education has ascertained and determined, and does hereby ascertain and determine, that the sum of \$61,181,000 be levied as a special tax for educational purposes, and the sum of \$13,000,000 be levied as a special tax for operations and maintenance purposes, and the sum of \$2,500,000 be levied as a special tax for transportation purposes, and the sum of \$-0- be levied as a special tax for working cash fund purposes, and the sum of \$1,553,000 be levied as a special tax for municipal retirement purposes, and the sum of \$1,882,000 be levied as a special tax for social security purposes, and the sum of \$-0- be levied as a special tax for fire prevention and safety purposes, and the sum of \$-0- be levied as a special tax for tort immunity purposes, and the sum of \$6,500,000 be levied as a special tax for special education purposes on the taxable property of Geneva Community Unit School District No. 304, Kane County, Illinois for the year 2023; and

**WHEREAS**, the Board of Education has ascertained and determined, and does hereby ascertain and determine, that it is in the best interests of the School District that the School

Treasurer exercise discretion to redistribute the property tax levy upon receipt and review of the extension calculations from the County Clerk of Kane County.

**NOW, THEREFORE, Be It And It Is Hereby Resolved as follows:**

**Section 1.** That the recitals set forth hereinabove are incorporated herein as if fully set forth and restated in this Section 1 *verbatim*.

**Section 2.** That the foregoing amounts shall be certified and returned to the County Clerk of Kane County as the tax levy of Geneva Community Unit School District No. 304 for the year 2023 on or before the last Tuesday in December 2023.

**Section 3.** That the School Treasurer of this School District is hereby authorized and directed to receive and promptly review the limiting rate calculations and tax rate calculations prepared and distributed by the County Clerk of Kane County and, to the extent necessary due to the limitations of the Property Tax Extension Limitation Law, make such adjustments within the various funds of the District for which the District levied taxes, and direct the County Clerk to extend taxes in accordance with such adjustments.

**Section 4.** That the President and Secretary of this Board of Education are hereby authorized and directed to certify the tax levy in the foregoing amounts in the form and manner prescribed by statute and the Secretary of this Board of Education is hereby authorized and directed to file a certified copy of this Resolution, together with the annual certificate of tax levy of the School District, with the County Clerk of Kane County, Illinois.

**Section 5.** That all resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this Resolution shall be in effect forthwith upon its adoption.
