#### **Call to Order**

### Agenda Item 1: Public Forum

Speaker: Daniel Hayworth

Mr. Hayworth, representing a local Christian school serving military families, expressed interest in leasing or purchasing the Eastern Hills Middle School facility following its planned closure.

### Agenda Item 3: Public Forum

Two individuals addressed the Board:

- Beth Suiter (Harker Heights) shared concerns regarding her special needs child's care at Skipcha Elementary, citing safety lapses, inconsistent IEP documentation, and procedural issues during ARD meetings.
- Dina Vega (Harker Heights) discussed her son's delayed Associate Degree verification through Central Texas College and the Early College Program. She explained communication breakdowns between the district and college had affected her son's scholarship and employment opportunities.

### **Agenda Item 4: Information Items for Discussion**

## 4A. Discussion of Proposed District Academic Calendar for the 2026–2027 School Year

Presenter: Mr. Will Baker, Assistant Superintendent of HR

Mr. Baker presented two draft calendars developed through stakeholder feedback and committee input. Option **A** offered slightly more instructional minutes and one additional professional development day; Option **B** provided one more instructional day. Trustees discussed the importance of supporting new teachers through PD, scheduling implications for transportation, and balancing classroom time with staff development. No action was taken; this item will be brought back for consideration on November 18<sup>th</sup>.

#### 4B. Discussion of Killeen ISD Tax Roll for Tax Year 2025

Presenter: Ms. Kallen Vaden, Chief Financial Officer

Ms. Vaden presented the annual tax roll totaling \$107.7 million, reflecting a 4.2% decrease due to homestead and over-65 exemptions. She explained that district funding is based primarily on ADA, so tax roll fluctuations have limited impact on revenue. This item will be included on the next Consent Agenda.

## 4C. Discussion of House Bill 1481 – Student Use of Personal Devices and Implementation of Elementary School Cell Phone Lockers

Presenter: Mr. Micah Wells, Executive Director for Student Support Services

Mr. Wells reviewed House Bill 1481, which prohibits the use of personal communication devices during school hours. He proposed revisions to the Student Code of Conduct and presented lockable classroom storage cabinets for elementary schools. Trustees discussed securing cabinets to prevent theft while ensuring emergency mobility.

## 4D. Discussion of Board Policy ELA (LOCAL) – Campus or Program Charter: Charter Partnership

Presenter: Dr. Terri Osborne, Deputy Superintendent

Dr. Osborne presented the TASB model policy establishing the **Charter Authorization** process for KISD under the state's 1882 partnership framework. The policy outlines accountability, and partner oversight.

#### 4E. Discussion of Killeen ISD Charter Authorizer Mission and Vision Statements

Presenter: Dr. Terri Osborne, Deputy Superintendent

Dr. Osborne proposed mission and vision statements to guide the district's Charter Authorizer framework. The vision emphasizes innovation and opportunity for all students; the mission focuses on approving and holding accountable charter partnerships that elevate learning and optimize district facilities.

### **Agenda Item 5: Action Items for Consideration**

## 5A. Consideration of Turnaround Plans for Eastern Hills Middle School, Manor Middle School, and Palo Alto Middle School, and Public Hearing

Presenter: Dr. Terri Osborne, Deputy Superintendent

Dr. Osborne presented TEA-mandated Turnaround Plans for the three campuses, each with multiple years of unacceptable ratings. She summarized improvement frameworks focusing on leadership development, instructional coaching, and community engagement.

Dr. Osborne emphasized that each plan was developed collaboratively with campus principals and teacher leaders, to ensure alignment with district and state performance expectations. She explained that the proposed interventions include targeted instructional walkthroughs, increased use of data-driven lesson planning, and mentoring for teachers new to high-need campuses. Trustees asked clarifying questions regarding staff retention incentives and accountability. Dr. Osborne mentioned that a public survey will be made available soon.
