COVID-19 UPDATES

COVID-19 Updates

Superintendent Tim Lutz indicated Beltrami County COVID numbers are as high as they have ever been. There are currently 350 active cases in county and 19 people hospitalized. In district there were three staff members who tested positive for COVID and 49 students tested positive.

We are working with Sanford Health and Beltrami County to provide vaccine clinics for students ages 5-11. A vaccination clinic will be held on November 20, 2021 for children

ages 5-11 and followed by December 11 for their second round. Notices were sent to all parents of these children.

Jordan Hickman, Director of Human Resources, provided an update on the OSHA COVID-19 Emergency Temporary Standard (ETS) that requires employers (who have 100 or more employees) must develop, implement and enforce a mandatory COVID-19 vaccination policy or adopt a policy requiring employees to choose to either be vaccinated or undergo regular COVID-19 testing. The Minnesota Occupational Safety and Health Administration (MNOSHA) must notify federal OSHA of the action it will take within fifteen (15) days of the November 5, 2021, publication and adopt an ETS that is at least as effective as the federal OSHA ETS within thirty (30) days. As an OSHA-approved state plan, MNOSHA must be as effective as federal OSHA in enforcing safe and healthful working conditions.

Resolution Establishing Combined Polling Places for Multiple Precincts and Designating Hours During Which the Polling Places Will Remain Open for Voting for School District Elections Not Held on the Day of a Statewide Election

Attached is the resolution establishing combined polling places for any school district election which is not held on the day of a statewide election. This is in response to the new legislation adopted in 2017 which requires school districts to establish combined polling places each year by December 31. The combined polling places designated in the resolution are the polling places for the following calendar year unless a change is made in the case of an emergency or because the polling place has become unavailable.
