# **BOARD AGENDA ITEM Board of Trustees Meeting July 24, 2018**

## Consider Approval of Low Attendance Days Waiver

## **SUMMARY:**

This item requests approval to apply for a low attendance day waiver from the Texas Education Agency (TEA). As allowed by TEA, "districts or campuses can request a waiver to excuse any instructional day(s) from ADA and FSP funding calculations that have attendance at least 10 percentage points below the last school year's average attendance due to inclement weather, health, or safety-related issues.

As indicated in the documents attached, Gonzalez for Young Children, Windle School for Young Children, Evers Park Elementary School, and Hodge Elementary each realized a 10% or more drop in their average daily attendance for 2017-2018 as compared to the 2016-2017 school year. The low attendance for each of these campuses is health related due to an increase in flu cases among our youngest students.

Consideration of the low attendance rate recognized on dates provided above in the summary of ADA percentages, may have a fiscal impact if the waiver is not submitted allowing the average daily attendance of these days to be calculated as an instruction day in ADA and FSP funding calculations.

## **BENEFIT OF ACTION:**

Approval of this action allows the District to submit a low attendance day waiver for the dates referenced in the summary of ADA percentages, to excuse these days from instructional days in calculating ADA and FSP funding.

Texas Education Agency will process the formal request as approved by the Denton ISD board of trustees.
