BACKGROUND INFORMATION

On June 1, 2009, the Board adopted current policy language regarding Authority to Obligate the District (Board Policy DJ), which updates the School District's Public Contracting Rules in accordance with State Recommended Model Rules. Appropriate bidding procedures and Public Contracting Rules have been complied with before recommending the attached contract for Board approval. The following authorization of contract, subject to available budget appropriations, is a routine Board action that appears under the consent grouping of the Board agenda.

PROJECT NAME: Aloha High School Career and Technical Education (CTE)

Improvements

PROJECT TIMELINE: September 2016 – October 2017

PROJECT BUDGET: \$2,000,000.00

PROJECT SCOPE: Remodel several classroom spaces to accommodate CTE programs including: computer programming, robotics, media/film, CADD, construction, and marketing.

CONTRACT NAME: Aloha High School CTE Planning & Design Services

SOLICITATION METHOD: Direct appointment.

CONTRACT TIMELINE: September 2016 – October 2017

CONTRACT AMOUNT: \$254,031.00

Original award was \$34,000 for Phase I with an expectation that the total architect/engineering services would be under \$100,000 for all phases. However, the cost for Phase II (design development (DD), preparation of construction documents (CD), and permitting) required an amendment of \$220,031 which was executed by change order.

CONTRACT SCOPE: Planning, design, permitting, and construction administration. Phase I provided the feasibility study and schematic design. Phase II (this change order) provides the DD, CD and permitting assistance work. Phase III, for construction administration services, will be negotiated at a future date.

RECOMMENDATION: Authorization of award of contract change order to OH Planning and Design Architecture.

FUNDING SOURCE: Construction Excise Tax
