PURPOSE

[This policy establishes the Clackamas Community College Board of Education structure, eligibility requirements, and zoned election process in accordance with Oregon law, ensuring fair representation and legal compliance.](#)

BODY OF POLICY

The [Clackamas Community College Board of Education](#), will consist of seven members elected by zones for four-year terms in accordance with [Oregon law \(ORS 341.326, 341.327, and 255.335\)](#) and be known as the Board of Directors. [The term of a Board of Director elected shall commence on July 1 following the election and expire June 30 following the regular district election at which a successor is elected.](#)

A person is eligible to serve as a Board member if [they/he/she are/is an elector of the Clackamas Community College District residing within the zone for which they are seeking to serve and has resided within this zone for at least one year immediately preceding the election or appointment.](#) An elector ~~is~~ [means an 18 year old or older individual qualified to vote under Section 2, Article II of the Oregon Constitution. The individual must be 18 years of age or older, who has registered to vote at least 20 calendar days immediately preceding the any election, as required by law in the manner provided by law and must have been a resident within the community college district for one year immediately preceding the election or appointment. He/She must also reside in the zone from which he/she is nominated, elected, or appointed. A newly elected or appointed board member must qualify for office by taking an oath of office.](#)

~~No person who is an~~ [Employees of Clackamas Community College are not the community college district is eligible to serve as a Board member while so employed by the district.](#)

[The Clackamas County Elections Office conducts the district's elections. Board Director elections shall be held on the third Tuesday in May during each odd-numbered year. Board Director appointments are](#)
