AVID Program for all Early College Information
High Schools for 2025-2026 Discussion

BACKGROUND:

Advancement Via Individual Determination (AVID) is a nationally recognized program designed for a segment of a school's population that is usually overlooked or is not served through local, state, or federal programs. AVID students are not typically high academic achievers yet possess the talent to be more successful if given the right help. AVID requires these identified students to take an AVID class where they learn studying and organizational skills and are provided tutorial assistance. The goal is for every AVID student participant to successfully enter and complete post-secondary education. This agreement allows campuses to use the AVID curriculum, buy and/or add to the AVID library, send teachers to AVID trainings, and have all rights to use all AVID logos, etc. It also provides access to the online AVID web page and AVID resources.

FISCAL IMPLICATIONS:

Budgeted local and categorical campus funds for all Early College High Schools for a total of \$43,163.00.

RECOMMENDATION:

Recommend approval to renew the AVID Memorandum of Agreement for all Early College High Schools for \$37,163.00 from budgeted local and categorical funds for the 2025-2026 school year. Services and items to be purchased are subject to the district's needs and funding.
