Items B, D and F were withdrawn from the consent agenda for separate discussion and consideration.

It was moved by Laure Searls, seconded by Patricia Mendoza and carried unanimously to approve all items under the Consent Agenda except B, D and F.

Laure Searls noted for the record a check received from Judge Gonzalo Garcia. It was then moved by Laure Searls, seconded by Adrian Medina and carried unanimously to approve Item B – Attendance, Financials and Warrant List for November 1-30, 2013.

Adrian Medina read aloud donations made to the district noting the importance of recognizing donors. It was moved by Adrian Medina, seconded by Sergio Coronado and carried unanimously to approve item D – Acceptance of Donations.

It was moved by Laure Searls and seconded by Adrian Medina to refer Item F – Update 98 back to the Policy Committee in January. After discussion the motion and second were withdrawn and Mrs. Searls moved to take Item F – Update 98 to January's Policy Committee for discussion and the second reading to the January 21st regular board meeting for final approval. Sergio Coronado seconded the motion which carried unanimously.

7. NEW BUSINESS

A. Discussion and possible action regarding the 2012-13 External Audit

It was moved by Armando Rodriguez, seconded by Adrian Medina and carried unanimously to approve the external audit as presented.

B. Reyes School - Discussion and possible action regarding VEMAC Amendment

Dominic Padilla presented details of an amendment for VEMAC with administration's recommendation to approve the amendment for building concrete, structural steel (material and erection), steel allowance, plumbing, elevator, masonry and associated fees and contingency per the VEMAC Amendment Cost Breakdown. He noted that an allowance of \$50,000 was inserted into the Amendment due to a discrepancy in steel tonnage and an allowance of \$25,000 due to a discrepancy in concrete. The allowances along with the applicable fees shall be refunded to CISD if not expensed.

It was moved by Armando Rodriguez, seconded by Patricia Mendoza and carried unanimously to approve the VEMAC amendment as presented.
