Subject: Ellucian Banner – Oracle License

Recommendation: Approve the Ellucian Banner Oracle license for FY 2024.

Background and Rationale:

The College's on premise Ellucian Banner software requires the use of Oracle application software for data management. The current license is required to maintain our student information system server environment and data warehousing needs.

The College is a member of the Texas Connection Consortium (TCC), which holds an Interagency Contract for Services for FY2024 with Lamar Institute of Technology (LIT). LIT holds a Master Agreement with Ellucian which allows TTC members to use that Interagency Contract to satisfy State of Texas bid requirements, as required by Texas Education Code 44.031 Section a, (4).

This license was budgeted for as part of the FY 2024 IT budget.

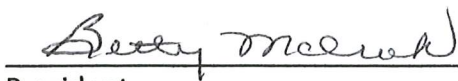

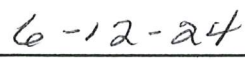
