Kyle Luedtke Superintendent	 Libby Cheever and I are exploring options for our health insurance provider and coverage. We have spoken with insurance brokers M3 and SF about possibilities. Our curriculum committee needs to review our health curriculum, in paticular the human growth unit. We will then need the board members who are on the Educational Program Committee to join the group for a meeting this spring. The Consumer Price Index for July 1, 2025 is 2.95%. This should be considered a starting point as we consider budgeting for next year. One of the goals of the district is to recruit, coach and retain quality staff. Sign Solutions 4U (ICCPA) approached the district about their process of window displays. They assist with heat/cooling retention, safety and branding. I had them mock up a front door display for the elementary school highlighting our Blue Ribbon Award. No decision has been made. This would be built into the 25-26 maintenance budget.

Middle school teachers set classroom goals that 80% of students would demonstrate growth on the winter tests. These goals were successfully achieved in 6th, 7th and 8th grade! Well done team! A DPI required advisory committee is being formed to approve the Human Growth and Development standards that the Frederic School District will be including in our Health Education curriculum. Students who are currently receiving intervention programming through an ACT 20 required Reading Plan, will continue to receive daily direct instruction from our district Reading Specialist throughout June Summer School.
Jada Anderson Pupil Services Director	 Onboarded our new nurse, Adrianna Addison this past month. She met with our lead secretaries in both buildings to ensure we were up to date and compliant with all things health related. Had our second progress monitoring call with DPI for our Joint Federal Notification work that we have been doing this year. The representative at DPI was very impressed with the hard work we have put in to break down our unit assessments (district wide) to ensure that they align with the essential standards that we identified at the beginning of the year. CESA has also asked to use our template as a resource to share with other districts as they have been impressed as well. CPI renewal training was conducted during the last January 20th inservice. The staff in that training included administration, custodial staff, and special

education staff. About 17 staff members are now re-certified in Crisis Prevention training to ensure the safety of all students in the district.
