## Re: Proposed June 2014, CHS Varsity bi-annual Cheer Competition

- 1. Educational goals While the overall purpose of the trip is a cheerleader competition against teams across the world, we hope to expand the cheerleader's global understanding through a variety of Hawaiian landmarks.
  - a. Pearl Harbor tour No trip to Oahu would be complete without visiting Hawaii's most popular tourist attraction ... the **USS Arizona Memorial**. The tours feature such things as the Arizona Memorial visitor's center, documentary film, and the ferry boat ride which takes you out to the memorial. From there you will gaze down into the water where just below the surface lies the decks of USS Arizona, final resting place for many of the 1177 crew members who lost their lives on December 7, 1941.
  - Diamond Head Hawaii's most recognized natural landmark is known for its historic hiking trail, stunning coastal views, and military history. Diamond Head State Monument encompasses over 475 acres, including the interior and outer slopes of the crater.
  - c. Ocean excursion This could comprise of several different things. In the past we have gone snorkeling in a Hanauma Bay, catamaran trip, and whale watching.

- 4. Travel Costs:
  - a. Registration and accommodations (not including airfare) \*\*Please note all registration and hotel accommodations must be booked through the Aloha Spirit corporation. Registration must be paid prior to January 1 to take advantage of the Early bird pricing. Hotel rooms will need to be blocked by January 1 as well.
  - b. Registration Fee \$135.00 per participant if paid prior to January 1. Coaches have free registration.
  - c. Hotel Option A Waikiki Beach Marriott \$165.00 per night per room (4 occupants for student room and 2-3 coaches for sponsor room)
  - d. Hotel Option B Aston Waikiki Beach Hotel \$181.00 per night per room (4 occupants for student room and 2-3 coaches for sponsor room)
  - e. Airport transportation:
    - i. Speedy Shuttle \$30.00 round trip \$480.00 total for all students
    - ii. Honolulu Airport Shuttle 8 passenger van \$320.00 round trip (3 vans needed) - \$960.00 total for all students

- 7. Financial accounting: We have been fundraising for the last four years for the Varsity 14-15 trip.
  - a. Booster club \$27,000.00 (currently)
  - b. Activity account \$25,000 (currently)
