STAFF RECOMMENDATION: That the Board review and adopt changes to the above listed LOCAL policies as recommended by TASB Community College Services and according to the Instruction Sheet for TASB Localized Policy Manual Update 49. (See TASB Community College Policy Reference Manual Update 49 and Localized Policy Manual Update 49, for annotated LEGAL and LOCAL policies). These include new policies, revisions, and deletions necessary to maintain compliance with state and federal law, align with the Texas Higher Education Coordinating Board (THECB), and improve internal governance and operations.

ORGANIZATIONS AND HAZING

BACKGROUND: TASB Local Policy Manual Update 49 incorporates changes stemming from the 88th Regular Legislative Session, federal regulatory updates, and reorganizations within the policy framework. Significant policy actions for Laredo College include:

- New Local Policies:
 - BCA(LOCAL) Clarifies Board officer duties and selection procedures.
 - BCB(LOCAL) Outlines structure and authority of Board Committees.
 - BCE(LOCAL) Establishes Advisory Committees composed of staff, students, or community members.
 - CGF(LOCAL) Codifies law enforcement structure, including peace officer duties, mutual aid agreements, and body-worn camera use.
 - FLBC(LOCAL) Implements hazing prevention and reporting procedures aligned with the federal Stop Campus Hazing Act.
- Revised Local Policies:
 - CG(LOCAL) Expands the Comprehensive Safety Program responsibilities.
 - DIAB(LOCAL) and FFDB(LOCAL) Clarify the scope of retaliation protections, reporting processes, and updates in discrimination complaint procedures for employees and students respectively.
 - ECC(LOCAL) Updates the policy on dropped courses to reflect current Coordinating Board rules, including expanded exemptions and appeal options.
- Deleted Local Policies:
 - CHA(LOCAL) and BCAC(LOCAL) Content from these policies has been reorganized and incorporated into CGF(LOCAL) and BCA(LOCAL), respectively.

These changes align local policy with updated legal mandates, ensure operational clarity, and reinforce institutional compliance expectations.
