1. **GCBDA/GDBDA-Family and Medical Leave-**There continues to be significant changes in Oregon law regarding leave. This includes changes from SB 1515 (2024) and numerous rule changes to match.

The biggest change governs what conditions qualify for leave taken through the Oregon Family Leave Act (OFLA) and Paid Family and Medical Leave Insurance (PFMLI). While these leave allotments used to run concurrently in many situations, they now cannot be taken concurrently. **Presenter:** Bernadette Adeniran (MESD)

- a. Updates reflect changes in Oregon's Paid Family and Medical Leave (PFML) policies following Senate Bill 1515.
- b. Policy revisions aim to make leave benefits more accessible for staff.
- c. Clarification was provided on how PFML interacts with OFLA (Oregon Family Leave Act) and FMLA (Family Medical Leave Act).
- d. Discussion on how staff will be informed about changes, including onboarding materials and possible additional training efforts.
- e. **Decision:** Approved for submission to the board under consent agenda.

2. **GCBDF/GDBDF-Paid Family and Medical Leave Insurance**There continues to be significant changes in Oregon law regarding leave. This includes changes from SB 1515 (2024) and numerous rule changes to match.

The biggest change governs what conditions qualify for leave taken through the Oregon Family Leave Act (OFLA) and Paid Family and Medical Leave Insurance (PFMLI). While these leave allotments used to run concurrently in many situations, they now cannot be taken concurrently. **Presenter:** Bernadette Adeniran (MESD)

- a. Further elaborates on leave eligibility and benefits.
- b. Clarifies the district's use of a third-party administrator for processing leave requests.
- c. Aligns with updated state regulations.
- d. **Decision:** Approved for submission to the board under consent agenda.
- **3. JHCD-Medications-**There were a host of changes in Oregon law and administrative rules around administration of medication to students and for student self-administration in a school/ESD setting. This includes changes from House Bill 2002 and 2395 passed in the 2023 Legislature; from Senate Bill 1552 passed in the 2024 Legislature affecting statute in ORS 339.866 339.871; and rules on administration of medication in OAR 581-021-0037 which include new rules on short-acting opioid antagonist.

The Oregon Department of Education has put together some additional resources Opioid Overdose Information and Resources which include a template letter to support communication with parents and other toolkits. Other resources on medications in schools are here.

The resulting changes are quite extensive and therefore the model policy and administrative regulation are presented without showing tracked changes. **Presenter:** Heather Severns

- a. Updates reflect state legislative changes.
- b. Includes administration of Narcan (opioid antagonist) by staff in life-threatening situations.
- c. Discussion on how this policy is communicated to families and staff training on medical emergencies.
- d. **Decision:** Approved for submission to the board under consent agenda.
- **4. JFG-Student Searches-**This policy has been updated to reflect MESD's practices. Presenter, Sascha Perrins.
  - a. Policy updates align with current district practices regarding student searches and law enforcement interactions.
  - b. Changes clarify legal requirements and district obligations.
  - c. **Decision:** Approved for submission to the board under consent agenda.

- **5. KN-Relations with Law Enforcement-**This policy has been updated to reflect MESD's practices. Presenter, Sascha Perrins.
  - a. Policy updates align with current district practices regarding student searches and law enforcement interactions.
  - b. Changes clarify legal requirements and district obligations.
  - c. **Decision:** Approved for submission to the board under consent agenda.
- **6. GBM-Staff Complaints-**This policy has been updated to reflect MESD's practices. Presenter, Sascha Perrins.
  - a. Clarifies the distinction between negotiated agreements (e.g., salary, benefits) and complaints, ensuring that contract issues are addressed within their appropriate channels.
  - b. **Decision:** Approved for submission to the board under consent agenda.
