The last two District 97 schools in need of secured entrances are Mann & Whittier and one was scheduled for the summer of 2012 and one for the summer of 2013 but we accelerated the summer 2013 to this year and thus would have all District 97 schools with secured entrances. These projects were included in our 5-year Capital Plan and supported by FAC to have done this summer.

An appropriate legal notice was published in the <u>Oak Leaves</u> on January 19, 2012 announcing a bid opening on February 7, 2012 (see attached legal notice). Apart from the legal notice, 13 contractors were invited to bid by DLA Architects (see attached bidders' list) and, on February 7, 2012, eight bids were received, ranging from a low of \$1,373,000 to a high of \$1,821,000 (see bid tab summary). We have sufficient dollars in our most recent DSEB (Debt Service Extension Base) borrowing (\$5,200,000) to cover the cost of this work.

The District's architectural firm has recommended award of a contract to Vengar Construction Corporation in the total amount of \$1,373,000 recognizing that this firm is the low bidder, and "has successfully worked for the District in the past". The Director of Buildings & Grounds and I are recommending support in awarding this bid to Vengar Construction Corporation.

This will return to the Board of Education for formal approval at its February 28, 2012 meeting.

On January 19, 2012, an "Advertisement For Bid" for the subject project was published in the local newspapers. In addition, DLA Architects, Ltd. invited the following thirteen general contractors to bid: Doherty Construction Co.; Frontier Construction, Inc.; George Allen Construction Company; Happ Builders, Inc.; Henry Bros.; IHC; International Contractors, Inc; Lamp Incorporated; Leopardo Contracting, Inc.; Metropolitan Corporation; Shales McNutt Construction; Sigalos and Associates; Vengar Construction Corporation.

A pre-bid meeting for the project was held on January 26, 2012. The following six contractors attended the pre-bid meeting: Boss Carpet One; Frontier Construction, Inc.; Henry Bros.; Master Project, Inc.; Metropolitan Corporation; Vengar Construction Corporation.

On February 7, 2012, eight bids were received for this project, all from qualified general contractors. Enclosed is a copy of the bid tabulation form. The apparent low bidder for the project is Vengar Construction Corporation with a Base Bid #1 in the amount of \$1,373,000 and with a Base Bid #2 in the amount of \$1,399,000.

Base Bid #1 includes the remodeling work at Mann and the Base Bid remodeling scheme at Whittier. Base Bid #2 includes the remodeling work at Mann and the Alternate remodeling scheme at Whittier. I have attached both the Base Bid plan and Alternate plan of Whittier for your reference so the District can decide which base bid to proceed with. Each base bid amount includes a \$25,000 contingency allowance. Any unused portion of this contingency allowance will be deducted for the Base Bid amount and returned to the District.

There was an additional add alternate included in the project which is Alternate No. 2. Alternate No. 2 included adding additional base cabinets with countertops along the exterior walls in three of the new administrative offices at Mann (Office 102A, 102B & 102C). Based on the fact that Vengar Construction Corporation is the low bidder and has successfully worked for the District in the past, we recommend award of the contract to Vengar Construction Corporation.






FIRST FLOOR PLAN- MANN ELEMENTARY
