



#### SCHOOL BOARD ZONES AND SCHOOL ASSIGNMENTS

## Policy Issue/Situation:

Board members serve as the focal point for community questions for an assigned set of schools. With new schools under construction, the Board must consider the school assignments for Board members. While making these assignments, the Board should consider the geographic division of zones.

## **Background Information:**

Per policies BBB and BBBA, Board members are elected at-large and must satisfy the required residency requirements. Zones must be divided so as to be nearly equal in population according to the most recent census.

Zones were last redistributed in 2001. At that time, the difference in population between zones was as great as 100% (between zone 1 and zone 2).

As of the 2010 census, population in the Beaverton School District zones was:

Board members have a set of schools assigned for which they are the main point of contact for community questions. Five schools are either under construction or have previously not been assigned to a Board member:

- New high school
- New middle school
- New elementary school
- Bridges Academy

## **BOARD ELECTIONS**

## 1. Number of Directors

The Board will consist of seven members elected at large and will be known as the District School Board

## 2. Designation of Board Positions

Board members' positions and their respective successors in office will be designated by numbers as Position No. 1, No. 2, No. 3, No. 4, No. 5, No. 6 and No. 7. In all proceedings for the nomination or election of candidates for or to the office of Board member, every petition for nomination, declaration of candidacy, certificate of nomination, ballot or other document used in connection with the nomination or election will state the position number to which the candidate aspires.

Individuals may seek more than one elected position such as school board and education service district board.

Re-elections for Board positions will occur as follows:

Position No. 1: May 2005, and every four years thereafter; Position No. 2: May 2005, and every four years thereafter; Position No. 3: May 2007, and every four years thereafter; Position No. 4: May 2005, and every four years thereafter; Position No. 5: May 2005, and every four years thereafter; Position No. 6: May 2007, and every four years thereafter; Position No. 7: May 2007, and every four years thereafter.

## 3. Board Zones

The School Board shall divide the seven district zones so that they are nearly equal in population, as shown by the latest federal census, taking into account school attendance areas.

## **Board Member Qualifications**

A person is eligible to serve as a Board member if he/she is an elector of the district. An "elector" means an individual qualified to vote under Section 2, Article II of the Oregon Constitution. The individual must be 18 years of age or older, registered to vote at least 20 calendar days immediately preceding any election in the manner provided by law and must have been a resident within the district for one year immediately preceding the election or appointment. Additionally, if the district is zoned, the individual must meet the requirements of ORS 332.124 - 332.126.

No person who is an employee of the district is eligible to serve as a Board member while so employed. A person who is an employee of a public charter school may not serve as a member of the Board of the district in which the public charter school that employs the person is located.
