Discussion was made on the siren request for the area west of Walter Road. An estimate for cost will be given to either Commissioner Francisco or Commissioner Bray to take before the Full Board. OLD BUSINESS

<u>I-12 Motor Vehicle Wrecker Policy Review:</u> Director of EM and E911 Services Kim Elkie presented the Motor Vehicle Wrecker Policy for review and approval. There was no language in the policy on accelerating disciplinary steps for towing services. The incorrect policy was included in the meeting packet and approval of the policy will be tabled pending updates regarding the appeal process and timeframe.

<u>I-25 Airport Emergencies Policy Review:</u> Director Elkie presented Policy I-25 Airport Emergencies for review and approval. Discussion was made to remove "One Frequency" from 25.1 subsection c. and include the Fire Command Officers (Fire Chief and Deputy Fire Chief) for notifications.

Motion was made by Tim Wade and supported by Chief Rob Edmonds to recommend approval of the Airport Emergencies Policy with updates as presented. Motion carried.

<u>IV-04 Dispatch of Medical First Responders Policy Review:</u> Director Elkie presented Policy IV-04 Dispatch of Medical First Responders for review and approval. Discussion was made to update ECHO Unit to TANGO/ECHO Unit and to remove ALS.

Motion was made by Nick Harrison and supported by Tim Wade to recommend approval of the Dispatch of Medical First Responders Policy with updates as presented. Motion carried.

<u>IV-06 Dispatch of Ambulance Policy Review:</u> Director Elkie presented Policy IV-06 Dispatch of Ambulance Policy for review and approval. Discussion was made regarding Hospice patients and not needing First Responders. Chief Edmonds will work with Nick Harrison for proper language to be amended at a future meeting.

Motion was made by Nick Harrison and supported by Tim Wade to recommend approval of the Dispatch of Ambulance Policy as presented. Motion carried.
