TITLE:

Introduction of Meet and Confer Teams for the 2018-2019 Fiscal Year, Addressing Working Condition Policies and Compensation Terms for Certificated, Support, and Professional/Non-Teaching Employee Groups

BACKGROUND:

Each year, a team of District representatives meet and confer with representatives of the Amphitheater Education Association, which serves as the exclusive meet and confer or "bargaining" agent for employees within the certificated, support, and professional/non-teaching employee groups.
