BACKGROUND: Annually the Athletic Department bids the District's requirements for athletic uniforms, equipment and supplies. Vendors registered with the Purchasing Department are notified when bids are available at the department's website. Vendors are advised of the District's intent to award each bid to a single vendor, however, the District reserves the right to award to multiple vendors if in the District's best interest. Multiple awards are made only when a single vendor cannot supply all the required items or, if it is in the District's best interest based on the price offered.

RFB 09-0053 Athletic Trainer Equipment one hundred and ninety-eighty line items: Six line items were no bid by all thirteen responding vendors. The remaining one hundred and ninety two lines items were split among two vendors; United Health (118) and Medco (74).

RFB 09-0054 Baseball & Softball seventy-six line items: Two line items were no bid by all fifteen responding vendors. The remaining seventy four lines items were split among two vendors; Buddy's All Stars and Sports Supply (56) and Medco (18).

RFB 09-0055 Basketball twenty-two line items: Fourteen vendors responded. Twenty-two line items were split among two vendors; Buddy's All Stars (15) and Sunvalco (7).

RFB 09-0056 Football seventy-six line items: Eleven vendors responded. Twenty-six line items were no bid. The remaining fifty line items were split between two vendors; Buddy's All Stars (31) and Sunvalco (19).

RFB 09-0057 Middle School Interscholastic Uniforms twenty-four line items: Eighteen vendors responded. The twenty-four line items were split between two vendors; Buddy's All Stars (19) and K&S Sports (5).

RFB 09-0058 Multi-Sport twenty-seven line items: Sixteen vendors responded. One line item was no bid. The remaining twenty-six line items were split between two vendors; Buddy's All Stars (16) and Sports Supply (10).

RFB 09-0061 Soccer twenty-six line items: Thirteen vendors responded. One line item was no bid. The remaining twenty-one line items were split between two vendors; Buddy's All Stars (17) and Striker Soccer (8).

RFB 09-0062 Tennis eleven line items: Eleven vendors responded. Eleven line items were split between four vendors; ATS Sports (5), Sports Supply (2), Greg Larson (2) and Bill Fritz (2).

RFB 09-0063 Track fifty-seven line items: Thirteen vendors responded. Three line items were no bid. The remaining fifty-four line items were split between three vendors; Buddy's All Stars (18), VS Athletics (26) and Cannon Sports (10).

RFB 09-0064 Volleyball twenty-one line items: Fifteen vendors responded. The twenty-one line items were awarded to Buddy's All Stars (21).

RFB 09-0065 Weight Room twenty-one line items: Nine vendors responded. Two line items were no bid. The remaining nineteen line items were split between two vendors; BFS Sports (13) and ADV Exercise (6).

RFB 09-0066 Wrestling fourteen line items: The fourteen line items were split between three vendors; Buddy's All Stars, (8), Universal Sports (6) and Alert Services (1).

RFB 09-0068 Health Services eighty-seven line items: Nine vendors responded. The eighty-seven line items were split between three vendors; Moore Medical (37), United Health (33) and School Health (17).

RECOMMENDATION: The Administration Recommends the Governing Board make the determination a single award is not advantageous to the District and approve the Award of Contracts for Athletic Uniforms, Equipment & Supplies to United Health Care, Medco, Buddy's All Stars, Sports Supply, Sunvalco, K&S Sports, Striker Soccer, ATS Sports, Greg Larson, Bill Fritz, VS Athletics, Cannon Sports, BFS, ADV Exercise, Universal Sports, Alert Services, Moore Medical, and School Health.
