When the preliminary 2017-2018 calendar was adopted by the Board of Education, June 4th through 8th were designated as emergency closing days. Assuming the use of all five emergency closing days, the last day of school was designated as June 8, 2018. Assuming the use of no emergency closing days, the last day of student attendance was scheduled as a full day on Thursday, May 31st and the last day for teacher attendance was a full Inservice Day on Friday, June 1st.

On Friday, February 9th, it was necessary to close school due to weather. Friday, February 9th was a half-day of student attendance due to parent-teacher conferences. Thus the District used one half of the five emergency closing days. Boards of Education typically approve the final school calendar for a school year during mid to late May. Once the final calendar is approved, the District may not use additional emergency closing days.

As a result of the use of one half emergency closing day, the last day of student attendance will now be a halfday on Friday, June 1st. The elementary schools will dismiss at 11:00 a.m. and the middle schools will dismiss at noon. The afternoon of Friday, June 1st will be designated as a Teacher Inservice Day. Teachers will finish their Inservice with a half-day of work on the morning of Monday, June 4th.

The Administration is recommending a final school calendar that establishes Friday, June 1, 2018 as the last day of student attendance (half-day morning only) and Monday, June 4th as the last day of teacher attendance (halfday morning only) for the 2017-2018 school year. Further, the Administration is recommending approval at the May 8th meeting in the unusual event that District would need to use an emergency day during the month of April.
