The scope of work includes but is not limited to underfloor and site reconstruction with the relocation of the existing mechanical yard, drainage improvements and water and sewer improvements along with landscaping, irrigation and all general construction (site work, HVAC, electrical, plumbing, etc.) as indicated in the contract documents. Expenditures will be made from Bond 2016 funds and Bond 2022 funds at a total estimated cost of \$13,549,000.00.
