## **PROPOSALS**

### **RENEWAL FOR TEMPORARY LABOR SERVICES**

**EXPLANATION:** The Deputy Director of Business and Technology Services requests that proposals be renewed for the purchase of temporary labor services. There is one additional renewal available on this proposal. **The renewal for Temporary Labor Services #1606 is renewed to Abacus Services, Burnett Staffing, Kelly Services, Pedigo Staffing & Trinity Staffing Services. The estimated annual award is for \$88,000.00 for this temporary staffing proposal.**

### **RENEWAL FOR SPEECH AND RELATED SERVICES**

**EXPLANATION:** The Deputy Director of Administrative and Instructional Services requested that proposals be renewed for the purchase of speech and related services. There are no additional renewal options available on this proposal. **The renewal for Speech and Related Services #1508 is renewed to Ardor Health Solutions; Assessment Intervention Management, LLC (AIM); Accountable Healthcare Staffing; Speech Facilitators; Cobb Pediatric Therapy Services; Speech Specialists of San Antonio, P.C.; Soliant Health, Inc.; Progressus Therapy, LLC; and Cumberland Therapy Services, LLC, for an estimated amount of \$370,000.00 by Districts using the services.**

There is one renewal option available on this proposal. **The renewal for K-12 online library databases #1602 is renewed to ABC – CLIO, BrainPOP, Capstone, Encyclopedia Britannica, EBSCO, Infobase Learning, NewsBank, ProQuest, Scholastic Library, Springshare, Tumbleweed Press and World Book. The estimated annual award is for \$1,100,000.00 for this DKC proposal.**
