There will be one teacher from each grade k-2 and one team for grades 3-6 that will have dual instruction no virtual only. Students will receive assignment through google classroom and Lincoln learning. Teachers will have a 30 minute block to ensure science of reading instruction is met. This block will be at a designated time and students are expected to log in during that time. There will also be set aside intervention time that students have the option to utilize.

I know it is too late to get questions answered, but these are the questions I have.

1. Virtual Arkansas
  - a. At least, 70 districts have stated in their plan that they will be using VA for some or all of their digital learning. Has staffing been a problem? Professional development?
  - b. Are you going to be able to stay under the teaching loads (190) that we previously discussed?
2. Malvern
  - a. How many elementary teachers will be virtual? virtual only or dual? Any simultaneous instruction?
3. Lead Hill
  - a. From the plan, it seems that there will be one virtual teacher K - 6 and one 7 - 12. How many students do you expect each teacher to have? Will secondary teachers have simultaneous instruction? What type of supports will these 2 teachers receive?
4. Hazen
  - a. Agenda says Pearson K - 6 and plan says Wilbur Mills. Will you be using Wilbur Mills as your provider?
5. Bearden
  - a. K - 6 is a blended plan. Describe how it is going to work. Is the face-to-face meeting going to be during the regular school hours? How many teachers will be involved at K - 6? Will there be simultaneous instruction?
6. Heber Springs
  - a. How many teachers at the lower elementary? Will they be virtual only? The plan states "some teachers will be virtual, some dual, and some simultaneous". Could you be

specific about where and when each type would occur?

7. Wynne
  - a. The DLP states that the Tri-Region will be used for K - 5 and Virtual Arkansas will be used for 6- 12. This is the first time we have seen a district use Virtual Arkansas for 6th grade. Could you give more information on the 6th grade with VA?
8. Mountain View
  - a. The plan shows Red Comet for grades 7 - 12. The agenda states that you will use Tri-Region Consortium for grades K-6. That is not found in the plan. Is it your intention to apply for K--6?
9. Prairie Grove
  - a. Only K -8 is in the plan. The agenda states you are asking for K - 6 through NwAR and 7-12 through Lincoln learning. Which is it?
  - b. The DLP stated that 5th and 6th grade students would be able to choose a plan A or plan B. How will the plan choice be determined?
10. Clarendon
  - a. --For grades 7-12 is it a district curriculum loaded on Canvas or will you be using the Virtual Arkansas Curriculum?
11. Blevins
  - a. For grades 7-12 is it a district curriculum loaded on Canvas or will you be using the Virtual Arkansas Curriculum?
