I, Idalia Vance, do not agree with the final recommendations of the Textbook Adoption Committee for subject Reading. The final recommendation of the committee was for the textbook ~~Mc~~ Texas Treasures by the publisher McMillan/McGraw-Hill. Stated below is the rational for my objections.

When looking at the three textbook adoptions and comparing them, I found that the McMillan/McGraw-Hill textbook does not have the same skills covering both the english and spanish versions. That was the main reason the majority of our campus voted for Scott Foresman Reading Street and Texas Treasures only received 1 vote.
