AGENDA ITEM: Consider Approval of Repair and Replacement of Fencing District-Wide

BACKGROUND INFORMATION:

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place. Additionally, the purchases of a class/type of product valued at \$50,000 or more in the aggregate for a 12-month period shall require Board approval.
- Taking into consideration prior purchases made during the 2018-2019 fiscal year from Gladiator Fence Company, LLC, the proposed purchases will put the District's total purchases from this vendor over the \$50,000 threshold stated in board policy.
- These proposed projects provide for the labor and necessary materials to repair and/or replace fencing at Aledo High School and Daniel Ninth Grade Campus tennis courts, Daniel Ninth Grade Campus soccer/football field, Bearcat Stadium football field area, Aledo High School baseball field, and Auxiliary Services/North Transportation lot. Several of these projects will enhance the safety of our students and district property.
- Subject to Board of Trustee approval, these projects have been scheduled for completion in summer 2019.

FISCAL INFORMATION:

The total cost of \$23,300 will be paid from available budgeted funds in General Fund 199.
