Description: Approval of the Head Start Budget Revision Grant Application (#06CH010831) for the 2023-2024 school year. The Office of Head Start (OHS), a division under the Administration of Children and Families within the Department of Health and Human Services, requests that \$328,171 be transferred from staff payroll to the Head Start general supplies, capital outlay, maintenance & repair, and contracted services for various program expenses such as operations, professional development, quality improvement, and technology investments.

Historical Data: The partnership between the Office of Head Start and the South San Antonio Independent School District (SSAISD) to fund the Head Start programs in SSAISD has been ongoing for many years. SSAISD has made significant contributions to our community by providing a supportive learning environment that promotes children's growth in key areas such as language, literacy, and social and emotional development. Additionally, SSAISD has recognized the vital role parents play as their children's primary educators. The Head Start program has been instrumental in helping us forge strong relationships with families, supporting their overall well-being, and addressing various critical areas of need.
