This is a request for information under the Illinois Freedom of Information Act, *5 ILCS 140*.

- Contractor reference letters submitted by Rockford Glass.
- Bid opening sign-in sheet(s) for project awarded to Rockford Glass.
- Bid tabulation sheet(s) used to evaluate qualifying bids awarded to Rockford Glass.
- Signed copies of Rockford Glass contracts.
- If employee background checks are required under any related Rockford Glass contracts, please provide copies of such background checks for all employees authorized to work on related projects.
- If workers are required to sign-in to access related Rockford Glass projects, I request copies of all related sign-in sheets.
- Submitted invoices associated with projects awarded to Rockford Glass.
- A certificate of participation in a United States Department of Labor Registered Apprenticeship Program.

If you are not the person charged with administering your public bodies FOIA obligations, please forward this request to the person charged with this responsibility. You may email those records to darvayo@pdc30.com. I understand that the Act permits a public body to charge a reasonable copying fee not to exceed the actual cost of reproduction. This request is not for commercial use; therefore, I am asking that any fees be waived.

I look forward to hearing from you in writing within five working days, as required by the Act. *5 ILCS 140/3*.
