a. StudioGC architecture+interiors Project(s) Update

I. Draft of Todd Hall Renovations

Athi Toufexis, StudioGC, presented the Draft of Todd Hall Renovations. This design iteration includes feedback and suggestions from Todd Hall staff. Athi explained that the renovation will include increasing classroom storage, updating to LED lighting, painting, and removing cable raceways. The plan is to keep the existing flooring.
