I. CALL TO ORDER: Chairman Peggy Katkocin called the meeting to order at 7:00 p.m.

V. SPECIAL PRESENTATION - CABE COMMUNICATIONS AWARD

CABE Representative Francis Walton presented New Fairfield with the Bonnie B. Carney award and explained the criteria for receiving this award. Dr. Cosentino thanked everyone involved with earning this award.

VI. PUBLIC PARTICIPATION - None

VII. BOARD AND ADMINISTRATIVE COMMUNICATIONS

A. <u>Chairman's Report</u> - Peggy Katkocin spoke of the proposed school construction projects and responded to some comments made at a recent BOF meeting regarding the role of the Permanent Building Committee. She noted that the PBC is not involved until the project is approved by referendum.

B. <u>Superintendent's Report</u> - Dr. Pat Cosentino spoke of the following:

• Noted that she reached out to a New Fairfield family that recently incurred a tragedy and offered thoughts and prayers on behalf of the school district. The family will let the Superintendent know if anything can be done to help in the near future.

• Noted that April 24th is Administrative Professional's Day and thanked all the administrative professionals throughout the district.

• Thanked Director of Buildings and Grounds Phil Ross for work that was done at Consolidated School over Spring Break.

• Thursday, April 25th is "Purple Day" to end the silence and stigma of substance abuse. Chris Herren will speak to the high school students during the day and again for the public in the evening. Dr. Cosentino encouraged parents and students to attend.

• Meeting House Hill School students will be singing at the Mets Game on April 26th.

• The "Say Something" initiative started today. This program comes from the Sandy Hook Promise and allows students to anonymously report suspicious behavior.

• Dr. Cosentino spoke briefly of her trip to Finland. She will do a formal presentation about this experience in the near future.

C. Student Representatives' Report - None

D. Committee Reports

1. <u>Business Operations/Research Management</u> - Ed Sbordone noted that this committee met on April 23rd and approved to bring budget transfers and the transportation contract to the full board. They also reviewed budget vs. actual expenditures and everything is in line. E. <u>Liaison Reports</u>

1. <u>Board of Finance</u> - Ed Sbordone noted the BOF met on April 17th and discussed the proposed high school and Consolidated School projects and several cost options. They also discussed the medical plans. Votes on the medical plan were tabled until a future meeting.

2. <u>Parks and Recreation Commission</u> - Kimberly LaTourette noted that the Parks and Rec Commission met on April 8th and discussed the boat docks and who would be responsible for closing the fields in case of inclement weather. They also discussed ensuring that there are parking spots available for community residents at the dog park and the playground. The Sip and Stroll will be held on Saturday, May 18th. There will be summer concerts at the gazebo on Memorial Field.

3. <u>Permanent Building Committee</u> - The last PBC meeting was cancelled. The next meeting will be on May 2^{nd} at 5 p.m. immediately prior to the BOE meeting.

4. <u>School Security and Safety Committee</u> - Dr. Cosentino noted that a lot of progress has been made regarding safety in the schools. A lot of money has been put into the proposed 2018-2019 budget for safety. She encouraged everyone to support the budget that includes the added safety features.

VIII. INFORMATION ITEMS

A. <u>Social Emotional Learning/Zones of Regulation</u> - Consolidated School Principal Rob Spino spoke of an initiative at Consolidated School that gives outlines for the behavioral expectations for students. He introduced Consolidated School teacher Jen Parker who explained that the program uses a tier approach. All students are involved in this initiative in the beginning and then additional resources are given to students as needed.

Consolidated School Assistant Principal Karen Gruetzner spoke of the process for implementing this initiative and noted that they have already seen results and specifically fewer office referrals. She spoke of the timeline for this initiative and next steps.

B. <u>NFHS/Consolidated School Concept Design and Cost Estimates</u>

Dr. Sanzo introduced Rusty Malik and Angela Cahill from QA+M and Chuck Warrington from Colliers to speak of the proposed building projects for both Consolidated School and New Fairfield High School.

Mr. Malik gave a recap of the facility needs and enrollment projections. He spoke of educational programs along with security needs and space needs. Common themes from other districts that can be applied to New Fairfield were discussed. There was a brief discussion of the challenges of the existing buildings and sites and the cost of doing nothing.

Options for the High School include:

Option 1- Multiple Capital projects throughout the next 5-10 years. The challenge to this option is that most of the projects must be done in the summer and there is usually no economy of scale with doing one project at a time. There would be little or no State reimbursement to this option.
Option 2 - Renovate as new. It was noted that the State will most likely not give a reimbursement for this option.

3. Option 3 - New facilities. This would allow for an upgraded floor plan with plenty of site room. There would be little disruption to class time and would allow for a reconfiguration of the parking lot. Building new facilities would likely be eligible for State reimbursement.

Options for the Consolidated School include:

1. Option 1- CIP - Capital Improvement Projects. There would be little or no State reimbursement to this option.

2. Option 2 - Renovate as new. It was noted that the State will most likely not give a reimbursement for this option.

3. Option 3 - New facilities (Early Learning Academy). This would include building a new school possibly behind MHHS. There was a discussion of possibly housing some students in Meeting House Hill School. This would allow for a reconfiguration of the parking lot. Building new facilities would likely be eligible for State reimbursement.

Members of the Board of Education asked questions regarding the different scenarios for both schools. It was suggested that questions from residents be made public on the district website. It was also suggested that a "Building Tab" be created on the district's website to give information.

There will be school tours on April 30th at 6:30 p.m. and May 4th at 10 a.m. starting at Consolidated School. It was also noted that there will be a public forum regarding these projects on Thursday, May 2nd at 7:00 p.m. at the Community Room at 33 Route 37. The public is encouraged to get involved in the entire process.
