Presentations/ Recognitions

Dr. Richard Ownby presented the Exemplary rated Ginnings Elementary School with the Title I Distinguished Progress School by the Texas Education Agency. To achieve this honor, Ginnings had to maintain or improve its TEA accountability rating each of the past three years and meet other stringent requirements. To be named a Distinguished Progress School, Ginnings also met or exceeded its Adequate Yearly progress measures of English/Language Arts, Math and Attendance the past two years.

Denton Independent School District placed 14 students from Denton High, Ryan High and Guyer High Schools on the Texas Music Educators Association Texas All-State Choir, Band and Orchestra.

Students from Strickland Middle School and Wilson Elementary will represent the Denton Independent School District at the Organization of American Kodaly Educators national convention by performing with the organization's national choirs at March 20 at the Morton H. Meyerson Symphony Hall in Dallas.

Students from Ginnings, Houston and Stephens elementary school campuses have been honored by the Texas Art Education Association and are having their art work displayed at the State Capitol.

The Denton Independent School District recently received national recognition for its quality athletic program by having two players on the prestigious Parade All-American High School Football team. Ryan quarterback, Scotty Young and Guyer defensive tackle Taylor Bible became just the second and third Denton ISD players honored by the national magazine. Taylor Bible was named the Associated Press Defensive Player of the Year in Texas.

The Board recognized 91 students from its three high schools as part of a new annual program that honors student athletes for their academic success. All student-athletes must maintain a cumulative GPA of 3.5 through the first semester of the current academic year, represent Denton ISD in a positive light and have been approved as a selection by their varsity head coach.

Update on Stimulus Funds

Val Morgan, Director of Special Education presented the Board with an overview of how the Federal Stimulus funds have been used within the Special Education department. The district received \$4.2 million in stimulus funds that was allocated for special education including personnel, professional development, materials and equipment, capital outlay and travel for training.

Chris Shade, Director of Federal Programs presented the Board with an overview of how the district spent 1.4 million for Title I programs. The district focused on literacy, science and best practices in working with at-risk students. There was \$697,839 spent on literacy libraries for elementary schools and \$62,520 on literacy materials at the middle school level.

Dr. Ramsey read a statement from a presentation by Dr. Barr "A growing separation between those who are educated and those who are not; between those who enjoy economic prosperity and those living in the "other America" without an adequate income, adequate housing and adequate health A growing separation between those who are educated and those who are not; Or live out their life unemployed, underemployed, or unemployable"
