Fifty-five members of the Class of 2026 in District 200 have been recognized as Illinois State Scholars. The Illinois Student Assistance Commission (ISAC), the state's college access and financial aid agency, confers this important recognition of academic achievement to exceptional Illinois high school students annually. This year, nearly 19,200 honorees join the other outstanding students who have been honored since the designation was first introduced in 1958. The State Scholar formula calculation uses a combination of the ACT/SAT

test scores, class rank or the unweighted GPA, and class size. Illinois State Scholars generally rank among the top 10 percent of the state's graduating seniors. "We're extremely proud of the students who've put in the extra work to earn the designation as an Illinois State Scholar. We know these students all have bright futures ahead," District 200 Superintendent Mike Moan said. Each State Scholar designee receives a congratulatory letter from ISAC and can download an official Illinois State Scholar badge to display on their online profiles and social media platforms, as well as share with their high school counselors, colleges, and employers.

2. Class of 2026 High SAT Scores (1300+)

The Scholastic Aptitude Test (SAT) is one of two standardized college entrance examinations used across the country as a criterion for selection to colleges and universities. More than 2 million high school students took the SAT in 2025, including all Illinois high school juniors. Illinois students earned an average composite score of 966, based on a scale ranging from 400-1600. In District

V - COMMUNICATIONS

"Communications are a time for community members and District employees to express a point of view, not to debate an issue. Mr. Miceli announced that the D200 Education Foundation's Silent Auction has begun and that the Board's donation to the auction this year is a gift certificate to the Lake Geneva Cooking School and several bottles of wine.

VI - SUPERINTENDENT'S REPORT

Dr. Moan commented on the cold weather and explained that we used a traditional weather day last Friday due to the extreme cold. He reminded everyone that the first two weather days will be used as traditional snow days with no school, to be made up at the end of the year. Any additional weather days will be used as remote learning days.

Dr. Moan shared that beginning February 6th, the Woodstock High School theater department will be presenting Little Women. He encouraged everyone to attend one of the shows.

Dr. Moan also mentioned that the D200 Education Foundation's Silent Auction is in full swing with all bidding concluding on Sunday, February 1st. He noted that all money raised directly benefits our students. He thanked the Board for their generous donation.

VII - MONITORING REPORT

1. Best Buddies Program Update

Woodstock North High School Best Buddies Advisor Holly Ehlenburg began by explaining Best Buddies is an international, non-profit organization that creates opportunities for students to form one-to-one partnerships within the schools. Buddy pairs are created when a student with a disability is matched with a student without a disability. Ms. Ehlenburg noted that there are Best Buddies chapters in all 40 states as well as in 41 countries.

Creekside Best Buddies Advisor Julie Stone informed the Board that the chapter at Creekside Middle School was established in 2009 and has had as many as 150 kids participating. Officer meetings are held twice a month before school where kids plan the events. Many events are held each month and they have included pumpkin painting, a visit from Mr. and Mrs. Claus, a Hawaiian themed event, and Special Olympics.

VII - MONITORING REPORT (Con't)**1. Best Buddies Program Update (Con't)**

Ms. Ehlenburg noted that the Woodstock North High School chapter was established in 2012 and some of their events have included Boo Bowling and movies. They are particularly excited to host the Best Buddies Walkathon for Inclusion on April 26th.

Ms. Ehlenburg added that the Woodstock High School chapter of Best Buddies also began in 2012 and holds monthly events such as holiday sweater decorating and other art projects with students working together.

Each chapter has fundraising opportunities that help provide scholarships for students to attend the Best Buddies International Leadership Conference. Ms. Stone explained that one of their favorite events is the Polar Plunge. At Creekside, this means that the Woodstock fire department comes and sprays participants with their firehose. Best Buddies raised over \$14,000 last year and their goal this year is to increase that to \$15,000. Another fundraising activity is the Best Buddies Friendship Walk. This year, the walk will be held on April 19th at the Wintrust Arena.

Board questions included inquiring about the process to add the program at Northwood Middle and the elementary schools, how many special needs kids are at the schools who are able to participate, and are there any schools without a presence at this point.

This was an informational report only. No formal Board action was required.

IX - NEW BUSINESS**1. Second Quarter Review of the 2025-2026 Budget**

In her quarterly review of the status of the budget, Chief Financial Officer Julie Dillon pointed out several key factors and reported that revenues and expenditures in all three operating funds are on target and trending where they should be at the halfway point of the year.

Board questions included wondering if we've heard anything about the changes in the federal government and the impact they might have on state funding.

This is an informational report only. No formal Board action is required.

IX - NEW BUSINESS (Con't)2. Approval of 2026-2027 Fee Schedule

Ms. Dillon explained that the fee schedule is being presented tonight so that the District can begin working on the 2026-2027 budget. She reported that the general registration fees over the past 2 years have increased 5% per year and administration is proposing no increase for next year.

Kids Club remains one of the most affordable means of after school care and remains in high demand. Mrs. Dillon noted that a 5% increase in Kids Club fees is being proposed. Increases are also proposed for Pre-K and Special Education tuition rates. These increases are based on calculation of actual costs in FY26.

Mrs. Dillon advised that lunch fees are scheduled to increase \$.20 per meal. This is less than the allowable \$.40 per review with ISBE. Consistent with fees described above, increased lunch fees reflect the impact of inflation on food and supplies.

3. Approval of Policy Revisions for a First Reading

Associate Superintendent, Brian McAdow reported that there were 20 policies for the Board to consider for a first reading this evening. All policy revisions and additions come from PRESS and many of them are for continuous improvement. More than 10 of them have very minimal changes. Others have larger changes such as 4:10 and 4:30 that deal with financial and budgetary rules. Some of the deadlines have changes and we are already in compliance. Mr. McAdow noted that Policy 4:180 which is our harassment policy has additions on cyber bullying and also has AI language added. He added that Policy 7:150 has been rewritten and renamed. It used to be Agency and Police Interviews and it is now called Agency and Law Enforcement Requests.

One system that has been put in place is the stoplight system that explains where AI can be fully used, where it can be used in part and where it can't be used at all. He advised that the next AI meeting will be held on February 19th.
