Bids were publicly posted on Wednesday, March 4, 2020 in the Daily Herald.

On March 20, 2020 at 3:00 pm, bids were opened and read aloud for GMSN and GMSS Health/Life Safety Repairs.

Four (4) bidders responded. The results are shown below. The low bidder is highlighted.

The contractors submitting bids were:

Wm. Tonyan & Sons – McHenry, IL Bee Liner Lean Services – Oak Lawn, IL Slaten Construction, Inc. – St. Charles, IL Expedia Construction Corporation – Arlington Heights, IL

It is my recommendation that Slaten Construction, Inc. be awarded the Base Bid 2020 Health/Life Safety Repairs contract for \$326,773.00 plus Alternate A-S1 (GMSS LMC Acoustical Panels) for \$20,865.00, Alternate A-S2 (GMSS Cafeteria/Serving Coiling Shutter) for \$12,402.00 and Alternate A-S4 (GMSS Fire Alarm Panel Replacement) for \$8,025.00. This brings the total bid to \$368,065.00.

Dear Mr. Ney:

Bids for the above referenced project were received, opened and read aloud on March 20, 2020. There were a total of four (4) contractors who provided bids for this project. A copy of the Bid Tabulation is attached.

From discussions with the District, it has been indicated that the intended direction for this project is to accept the Base Bid plus Alternate A-S1 (GMS-South LMC Acoustical Panels), Alternate A-S2 (GMS-South Cafeteria/Serving Coiling Shutter), and Alternate A-S4 (GMS-South Fire Alarm Panel Replacement). This understanding allowed a narrowed focus for the bid review efforts between the first and second low-bid contractors. The bid values provided between these two lowest contractors were very tight, when considering some of the alternate options, with only a 6% separation, which indicates a similar understanding to the proposed scopes of work by these contractors.

The apparent low bidder, when considering the intended scope of work identified above, was Slaten Construction, Inc., from St. Charles, IL, with the following proposal amounts submitted:

During the bid review process, FGM Architects noticed some irregularities in the bid tabulation amounts for selected Alternate pricing. The following items were discussed with each apparent low bidding contractor and independently with Geneva CUSD304 and the items of particular note have been identified as follows:

ALTERNATE A-S4 – GMS-South Fire Alarm Panel Replacement:

Alternate A-S4, as presented, had Slaten Construction, Inc. well below the remaining field of bidders and Bee Liner Lean Services substantially above the remaining field of bidders. When communicated with each bidder, they referenced that they had the scope of work covered. Bee Liner Lean Services was placing a lot of contingency work within their bid number, including re-wiring some existing major devices/panels and also their own separate contingency amount of \$30,000.00. Slaten Construction, Inc. placed some of the supplementary electrical/re-wiring work within their Base Bid number and not in the Alternate pricing. FGM feels that they have the understanding of the expected scope of work that is required/identified within the Contract Documents, although Bee Liner Lean Services is projecting a worst-case scenario that may not be necessary.

SUMMARY:

We have reviewed the bid submissions with Slaten Construction, Inc. and they indicated their bids are complete and includes all work as specified in the Bid Documents. Also, they indicated they can complete the work as scheduled.

Based on reviewed information, their qualifications, and previous similar work last year for the District, we see no reason not to recommend award of a contract, for the identified scope of work listed above, to **Slaten Construction**, **Inc** for a total cost of \$368,065.00.

Please let us know your decision at your earliest convenience. Upon your direction, FGM Architects will draft a construction contract for review and then execution by the District and Contractor. We will also notify the contractor to proceed with the project once authorized by the District.
