President Schriemer called to order at 7:01pm.

I. SUPERINTENDENT'S REPORT

- I.A. Recognitions. Supt O'Neill welcomed everyone. O'Neill turned it over to Mr. Barwegen who turned it over to his students for their presentation.
- I.B. Legislative Update. Supt thanked the students and Mr. B for the presentation. He reports the state is working on things related to the federal items. Gov Whitmer announced her focus for schools. A few were cell phone policies, streamlining certification process, reading, and increasing secondary enrollment. He is not expecting a budget anytime soon.
- I.C. Important Dates. Supt O'Neill highlighted spring break, Mary Poppins production, and Sunset Lake's music program. He also gave a girls basketball Regional update that's happening right now. Winter sports highlights also included bowling and wrestling.

II. REPORTS AND PUBLIC INQUIRY

- II.A. Proposal for American History Since 1980 Kyle Roberts and Daryl Zartman. Gail Vandaff and Matt Brussee presented due to the basketball game attendance. Vandaff started by going over the process for launching a new class offering. Matt Brussee presented this class due to Kyle Roberts being at the basketball game. This class would offer topics to HS students who are very interested in things their parents may remember. They want to bridge the gap between where the US history class leaves off and current day. Burmeister, Centofanti, Willoughby, and Hostetler asked a few questions.
- II.B. Proposal for History Through Film Matt Brussee, Kyle Roberts, Daryl Zartman. Matt Brussee presented. He introduced a few of his current students who are excited about this class and wanted to support him. He learned about the class from Gull Lake because it was so well received. His survey of over 400 MS students showed about 70% of them were interested. This course is history but also research and critical thinking. He explained the

editing process which is now online for violence, swearing, and adult content. Burmeister, Centofanti, Hostetler, and Willoughby asked a few questions.
