

SPEECH LANGUAGE PATHOLOGY CONTRACT AGREEMENT

Geneva Community School District 304 agrees to employ Linda Lee Saflarski of LLS SLP LLC, for the provision of speech language therapy services. Payments to LLS SLP LLC will be made on a bi-weekly basis submitted by standard invoice. These payments will be based upon the number of hours spent in service to students at Geneva High School at the hourly rate of \$49.00.

IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO THAT:

I. THE SERVICE PROVIDER WILL:

- A. Perform Speech Language Therapy services in accordance with the Individual Education Program (IEP) for each individual student.
- B. Provide the following services through the assigned therapist:
 1. Set up appropriate treatment plans and establish short and long term goals and objectives for inclusion on the Individual Education Program (IEP).
 2. Collaborate with related service staff for provision of services to individual students per the Individual Education Program (IEP).
 3. Share information regularly with the teacher/case manager who coordinates the educational program of individual students.
 4. Prepare clinical and progress notes for incorporation into the educational records of the students receiving therapy at the conclusion of each term.
 5. Prepare Service Logs to document student attendance to the therapy program and incorporate into the educational records of students receiving therapy.
 6. Provide assessment and evaluation services for individual students for inclusion on the Individual Education Program (IEP) or to determine eligibility for Speech Language Therapy service.
 7. Attend educational team meetings to report on student progress on the Individual Education Program (IEP); and/or to report results and recommendations from re-evaluations or initial evaluations to determine eligibility for Speech Language Therapy service.

- C. Provide professional liability insurance for Speech Language Therapy which will hold harmless the school district for possible incidents which may occur during treatment provided by LLS SLP LLC.
- D. Conform to all applicable policies and procedures of Geneva Community School District 304.
- E. Not attempt to collect for therapy services from either student, family, or any governmental, private, or public agency other than Geneva Community School District 304 during the period of this contract.
- F. Meet the certification and qualification requirements for Speech Language Pathologist, including current state licensure.
- G. Submit bi-weekly a prepared statement of charges to Geneva Community School District 304.

II. GENEVA COMMUNITY SCHOOL DISTRICT 304 WILL:

- A. Be responsible for payment of fees for services rendered by LLS SLP LLC, for students receiving Speech Language Therapy service.
- B. Reimburse LLS SLP LLC, on the basis of \$49.00 per hour for Speech Language Therapy services provided to individual students and consultation with parents and teachers/school staff.
- C. Submit payment for charges on the 15th and 30th of each month following receipt of the standard invoice from LLS SLP LLC.

III. This agreement will be effective from August 18, 2025 through November 13, 2025; unless amended by mutual agreement of the parties.

IV. If both parties agree to the provisions of this contract and no written modifications are requested, this Agreement shall remain in full force and effect unless and until one of the parties give thirty (30) days notice in writing to the other party of its intention to terminate this Agreement.

V. This Agreement holds harmless Geneva Community School District 304 for any liability incurred during the delivery of direct, collaborative or consultative treatment services provided by LLS SLP LLC.
