State and Federal Budget Update – The State of Oregon has forecasted upcoming revenue decreases and has asked each agency to create plans that cut 2.5-5% from their budgets. Final direction from the legislature and ODE is headed our way sooner than later, but we can expect that we will be implementing these cuts in the 26-27 budget.
